Subject: F.I.R for making fake registered General power of attorney being No.1 of 2005 and further using it to sell landed property of my principals by creating several numbers of false and fabricated deeds with respect to L.R Plot No.440 of Mouza :- Khopalashi, Block:- Matigara, District :- Darjeeling.

Respected Sir,

I. MD. BAISHAKU @ MD. NASIRUL, S/o Md. Mafijuddin, resident of Panchkelguri, Nima, Khopalasi, Post Office and Police Station- Matigara, Pin-734010, District-Darjeeling being the constituted attorney of 1) SMT SITA ORAON, D/o Late Bhakru Oraon 2) SMT RUPNI ORAON, D/o Late Bhakru Oraon 3) SMT. SUNITA LAKRA, D/o Late Bhakru Oraon 4) SRI BAGANU ORAON, S/o Late Bhakru Oraon, all No.1 to 4 resident of Khopalasi, Post Office:- New Champta, Police Station:- Matigara, District Darjeeling (W.B.) would like to lodge written complaint against following persons as follows.

1. That one JAGDISH PRASAD Son of Hari Narayan Prasad was the actual real/recorded owner of huge quantum of landed property measuring 20.15 Acres, recorded in R.S Khatian No.23/1, containing R.S Plot Nos.206, 264, 265, 211, 65, and 261 within Mouza:- Khopalashi, Police Station:- Matigara, District :- Darjeeling.
2. That all the above said R.S Plots got converted to L.R Plots and the said R.S Plot No.265 got converted to L.R Plot Nos. 439 & 440.
3. That R.S plot No. 265 comprised 5.86 acres of landed property out of which 2.96 acres of land is comprised under L.R Plot No.440 and 2.90 acres of land is comprised under L.R Plot No.439.
4. That the above said Jagdish Prasad being the owner of 2.96 acres of landed property in L.R Plot No.440 transferred 1.775 acres of landed property in favour of father of my principals namely BHAKRU ORAON

(Since deceased), Son of Late Tekra Oraon by virtue of registered deed of gift being No.2636 for the year 1988 registered at the office of the then Sub Registrar at Siliguri, in the district of Darjeeling situated within Mouza:- Khopalasi, J.L. No.21, under Police Station:- Siliguri, now Matigara, in the district of Darjeeling having permanent, heritable and transferable, right, title and interest therein, free from all encumbrances and charges whatsoever and the remaining land meaning 1.19 acres was never ever transferred by said Jagdish Prasad.

5. That the said Bhakru Oraon being owner in possession of above said landed property, died intestate leaving behind him his wife Lati Oraon (Now deceased), three daughters namely Smt Sita Oraon, Smt Rupna Oraon, Smt Sunita Lakra, and one son namely Sri Baganu Oraon.
6. That my principals i.e the legal heirs of Bhakru Oraon have given me and 3 others 3.5 Bighas of landed property out of their 5 Bhiga 6 Khathas of land for the purpose of cultivation of rice by virtue of registered of general power of attorney in the year 2017. It is pertinent to mention here that previous to that my principals used to cultivate the said land for agriculture purpose since last more than 20 years.
7. That it has come to my knowledge that one 1. Pradip Kumar Sahu Son of Late Muktanand Sahu 2. Dilip Kumar Sahu Son of Muktanand Sahu both No.1 & 2 resident of Khopalashi, Post Office:- New Champta, Police Station:- Matigara, in the district of Darjeeling, 3. TANKA NATH DAHAL Son of Late Chandra Prasad Dahal, resident of Darjeeling More, Durgaguri, ward No.45 of SMC, Pradhan Nagar, in the district of Darjeeling, (Phone No.9126412265), 4. SMT ANJALI PRADHAN, resident of TCP, Khaprail, Sainikpuri, in the district of Darjeeling by making a deep hatch conspiracy with each other has manufactured a false and fabricated registered power of attorney being document No. 1 of 2005 in the name of Satyendra Kumar Sahu and by using the said Power of Attorney has sold the land of my principals to various persons by several deeds. Be it mentioned here that legal heirs of Muktanand Sahu i.e Pradip Kumar Sahu Son of Late Muktanand Sahu 2. Dilip Kumar Sahu Son of Muktanand Sahu never became the owners of the L.R Plot No.440 but most astonishingly they have created a false power of attorney with respect of L.R Plot No.440 and sold the land of my principals to several persons in L.R Plot No.440.

8. That the above said land of my principal is in their possession since last many years and presently the above name 1. PRADIP KUMAR SAHU Son of Late Muktanand Sahu 2. Dilip Kumar Sahu Son of Muktanand Sahu both No.1 & 2 resident of Khopalashi, Post Office:- New Champta, Police Station:- Matigara, in the district of Darjeeling, 3. TANKA NATH DAHAL Son of Late Chandra Prasad Dahal, resident of Darjeeling More, Durgaguri, ward No.45 of SMC, Pradhan Nagar, in the district of Darjeeling, (Phone No.9126412265), 4. SMT ANJALI PRADHAN, resident of TCP, Khaprail, Sainikpuri, in the district of Darjeeling along with their men and goons are again and again trying to take the illegal possession of our landed property and they also destroyed a part of the rice cultivation on the landed property of my principals. That on our strong resistance they flew away with the threatening and warning that they will take the illegal possession of our landed property.

9. That the above said miscreants have also threatened me that they will implicate me in false criminal cases however above said miscreant has already filed false criminal cases against me and others.

10. That in the above said circumstances I request your good self to kindly register this complaint as F.I.R and take legal and strict actions against all the perpetrators of forgery and cheating as named in this F.I.R and all other persons who are found to be part of this conspiracy during the investigation of this case.
