The brief fact is that sir on 08/06/2022 when I along with C/830 Pradip Roy, CV/993 Anil Das was performing K-30-night Mobile van duty under Pradhan Nagar P.S area vide M.C.C No.1464 dt. 07/06/2022, I got an information at around 02:10 hrs from one viz: Anarul Islam (M-24) s/o Baharul Islam of Darjeeling More Gas Godown that some rowdies were harassing girls at Gurung busty who, were returning from their night duty from Webel IT, Matigara. Accordingly, I rush to the spot and found that there was a fight going on between two groups, I intervene into the matter and try to detain the rowdies to calm the fight but, in the meantime the above noted accused persons start abusing us using vulgar languages, assaulted me and deter us from lawful discharging of our duty also they damaged our on-duty vehicle back seat glass. To control the situation I informed the matter to duty officer of Pradhannagar PS for re-enforcement, accordingly he send the other 02 van officer and force. Then me, SI Benoy Tamang , ASI Maksud Ali along with force could apprehended the above noted five persons and bring then to PS.

Hence, I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted persons and arrange for its investigation, so that I would be able to discharge my duties without any fear.


