This is to inform you that I Sri Manish Ghosh S/O Late Sri Ramyopal Ghosh of G.P. Road, Deamatra, P.O. Sitaranjan Dist. Paschim Bardhaman, Pin-713359 checked in the hotel Debjoti today on returning from Darjeeling with my family and friends family. We were total 10 people (5 female & 5 male incl children). Sir, we contacted the hotel on phone with the manager and took 4 nos. of AC room. On reaching the hotel we checked into our rooms. We found the payment was taken in full cash i.e. Rs 6600/- for 4 rooms in advance as we were supposed to check out at 4am in the morning to catch the train from N.J.P.

Sir, one of the rooms AC was not working. We complained several times to the manager but the problem was not sorted. Instead the manager started abusing and threatening us. He told us to leave the hotel and no payment will be refunded. On hearing this that we will be thrown out of the hotel during midnight with our family we were in a state of total shock. When the manager and his boys along with his other people took out a baseball stick to hit us and made allegation that we were drunk and making mockery. We called the Siliguri Police to help us. Thanks to the Siliguri police for helping us to get out of that hotel as

at 11:00am we were finally unable to stay here with our family.  
Sir, I want to request you to kindly lodge a complaint against the hotel management & if possible to get our amount refund.
