1. That I am the Director of the land owned by the Company **SANYOG REALTORS PRIVATE LIMITED**.

2. That our company acquired the land measuring 13.55 Acres including land measuring about 20 bighas in plot No. 83, 84 & 106 of Sheet No. 12, recorded in R.S. Khatian No. 2732 & 920 of Binnaguri in the District of Jalpaiguri by virtue of Several registered Deeds of Conveyance.

3. That in the meantime, we mutated our name with the Record-of-Rights and the concerned departments have also issued separate L.R. Khatians, vide L.R. Khatian Nos. 1154 respectively and since then we are looking after the entire land.

4. That since few weeks some miscreants namely headed by Mehboob Rehman S/o Azizar Rehman, Moksidi Ali, S/o Jayuddin Md., Chatur Md, S/o Sirajul Md. (having contact Number - 7679876086 and 807696814) all are residents of Rangalivita , P.O. Satellite Township, P.S. Bhaktinagar in the District of Jalpaiguri-735135 are trying to enter into the land and take illegal possession of the same but due to strong resistance from the me and the other employee of the company they failed to do so.

5. That on (i.e, 26.05.2022) at around 1PM it came to my knowledge that the aforesaid persons along with few other anti-social element who are also the local land grabber are trying to enter into the land with an intention to trespass into the land and make illegal structure over the land .

6. That when I tried to stop them, one of the people caught hold of my collar and tried to choke me and pushed me on the ground. They also slapped me and threatened me of dire consequences. I then immediately informed my employer who then reached the spot and the miscreants left the place.
