child look birth since our marriage my husband
use to assault me physically, mentally as well
as sexually. My husband is a known Criminal in
our locality and many cases are pending against him
in Jalpaiguri Court. Whenever, he returns from his
work he tortures me with fists, kicks and blows and
anything in his hand. He never care and look after
upon me and my daughters and on my questioning
he assaults me mercilessly on my persons.

That yesterday 06.06.2022 at about 5:30 A.M. my
husband without any reason started bickering
with me and suddenly he attacked me with
knife on my persons with an intention to kill me
in the present of my daughters and land lord. As
a result I received several injuries. Anyhow I
saved myself from his hands. At present I am
took shelter at my paternal Aunt's house at
Majhabari.

I therefore, request you to kindly take
stringent legal action against my aforesaid husband
and save me from his hands and thus obliged.
