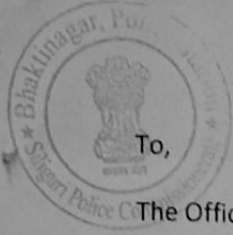

This is to state you that I Makhan Paswan father of Dipa Paswan residence of Prakash Nagar, Paswan Busty, Ward no.43, Siliguri, West Bengal. My daughter who is missing from today 10 AM i.e 07/06/2022.

She used to work in a house as maid and left house at 7.30 AM for her work as per her daily routine, but did not return home at 10 AM. We wait till 11 AM for her after that we started asking for her friends and our relatives as anyone has seen her anywhere. But we could not trace her anywhere. Her mobile phone is switched off from 11AM. She has taken Rs.6,000/- and mobile phone with her. She was wearing a jeans paint and white T-Shirt.

I have doubt on a boy named Abhay Dey Son of Manik Dey of our locality, I have heard from her friends that she used to talk to this boy on phone calls. Also we doubt of child trafficking as her age is under 18.

Please take necessary steps as soon as possible so that I can get my daughter back home.

I would be thankful to you for this sort of work for me.
