Sir,

In producing herewith one (01) arrested accused person namely Rabin Lama (25) S/O- BIRTHA Bahadur Lama of Sevoke Bazar, P.S- Kurseong, Dist- Darjeeling along with the following articles under proper seizure as per seizure list;

- a. One multi-colour nylon bag containing 24 (twenty-four) bottles of "Onereex" Cough Syrup (each bottle containing 100 ml) having Batch No. 07522-SD28, Mfg. Date: 05/2022. Exp. Date: 04/2024, seized from the Exclusive and conscious possession of above noted Rabin Lama (25) and marked as "Exhibit- A".

I, PSI Rantu Haldar, S/O- Manoranjan Haldar of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Rabin Lama (25) S/O- BIRTHA Bahadur Lama of Sevoke Bazar, P.S- Kurseong, Dist- Darjeeling to the effect that on 10.06.2022 at about 00.21 hrs I received a specific source input that one person, possessing huge quantity of 'Codeine Phosphate' based drugs, was standing at Salugara Kendriya Vidyalaya under Bhaktinagar PS to sell the same to his designed customers. The matter was diarized in Bhaktinagar PS GDE No.483 Dt. 10.06.2022 and subsequently, I informed the matter to the Inspector-in-Charge, Bhaktinagar Police Station in written and being directed, myself along with ASI Dipak Karmakar, Const- 986 Rajib Sarkar and CV/619 Dharmendra Roy CV/935 Biplab Barman all of Bhaktinagar PS, SPC along with investigation kit left for Salugar Kendriya Vidyalaya under Bhaktinagar PS by Govt. vehicle to verify the veracity of the information. This refers to Bhaktinagar PS GDE No. 484 Dt.10.06.2022 and M.C.C No-216/2022 Date- 10.06.2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Salugara Kendriya Vidyalaya under Bhaktinagar PS I contacted two persons namely (1) Sandeep Barman (21) S/O- Suresh Barman of Bhupendra nagar, W.No-42, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri, and (2) Mithun Roy (33) S/O- Prabir Roy of Chayan Para, W.no- 42, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived at Salugar Kendriya Vidyalaya under PS- Bhaktinagar at 00.50 hrs and subsequently, being pointed by my source detained 01 (one) person standing at Salugara Kendriya Vidyalaya. He had carried one multi-colour nylon bag in his right hand. Thereafter, we disclosed our identity and the information in hand and stated him that he as well as the bag under her possession will be searched for the purpose. And, I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but he did not search the police party. Consequently, I informed the matter to I/C Bhaktinagar PS regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Salugara Kendriya Vidyalaya under Bhaktinagar PS to remain present and to supervise the search and seizure.

Accordingly at 01.35 hrs Shri Amaresh Singh I/C Bhaktinagar PS acting as Gazetted officer of SPC arrived at the spot at Salugara Kendriya Vidyalaya under Bhaktinagar PS as Gazetted officer, SPC and in presence of two independent witnesses searched the detained person following all formalities, keeping her decency and recovered the above noted article from the exclusive and conscious possession of the accused person namely Rabin Lama (25) S/O- BIRTHA Bahadur Lama of Sevoke Bazar, P.S- Kurseong, Dist- Darjeeling

On being searched of the said detained person found 24 (twenty-four) bottles of "Onereex" cough syrup (each bottle containing 100 ml) containing 24 X 100 ml = 2400 ml i.e., equivalent to 2.4 Kgs. which was kept into a nylon bag carried by the detained person namely Rabin Lama (25) S/O- Birtha Bahadur Lama of Sevoke Bazar, P.S- Kurseong, Dist- Darjeeling

Further, on demand in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for acting as Gazetted officer of SPC the detained person namely Rabin Lama (25) failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 24 (twenty four) bottles [containing total 2400 ml i.e., equivalent to 2.4Kg] of "Onereex" Cough Syrup from the exclusive and conscious possession of above noted accused person namely Rabin Lama (25) at the spot at Salugar Kendriya Vidyalaya under Bhaktinagar PS under proper seizure list in presence of independent witnesses and Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for acting as Gazetted officer, SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labelled and sealed the seized articles in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for Gazetted officer, SPC and independent witnesses and the accused person namely Rabin Lama (25) The whole process of seizure was made in between 01.40 hrs to 02.15hrs.

Being further asked, the apprehend persons namely Rabin Lama (25) admitted in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for gazetted officer of SPC and other independent witnesses that She has procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. She also disclosed that he has been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Rabin Lama (25) is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Rabin Lama (25) S/O- Birtha Bahadur Lama of Seoke Bazar, P.S- Kurseong, Dist- Darjeeling after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person Rabin Lama (25) S/O- Birtha Bahadur Lama of Seoke Bazar, P.S- Kurseong, Dist- Darjeeling and arrange for its investigation.
