Sir,

In producing herewith four (04) arrested accused persons namely (i) Nandu Tirkey (23yrs) S/o- Sahuroy Tirkey of Chittaranjan Colony, Bagrakote, W/no- 20, PS- Siliguri, Dist- Darjeeling, (ii) Mukesh Mahato @ Muksha (26yrs) S/o- Lt. Kailash Mahanto of Tikiapara, Majdoor Colony, W/no- 28, PS- Siliguri, Dist- Darjeeling, (iii) Santo Das @ Guddu (22yrs) S/o- Jhantu Das of Ghugumali near Falbazar, W/no- 37, PS- Bhaktinagar, Dist- Jalpaiguri, (iv) Md. Abdul (20yrs) S/o- Moti Mahalla of Dangi para, W/no- 06, PS- Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

1. One (01) iron made sword measuring 23 inch (approx) including wooden butt from the possession of Nandu Tirkey which was kept concealed on his back side,
2. One (01) iron made Hasua measuring 17 inch (approx) from the possession of Mukesh Mahato which was kept on his right hand,
3. One (01) iron made sabol measuring 18 inch (approx) from the possession of Santo Das which was kept concealed on his back side,
4. One (01) iron made 'Knife' measuring 09 inch (approx) from the possession of Md. Abdul which was kept concealed on his left pocket.

I, ASI Debasish Das of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Nandu Tirkey, (ii) Mukesh Mahato, (iii) Santo Das, (iv) Md. Abdul and others namely to the effect that today on 08.06.2022 at 00.45 hrs received a sources information that 12/13 persons have assembled at **Siliguri Trading Corporation Indian oil, Burdwan road** under Siliguri PS with a view to commit dacoity at Khalpara area. The fact was diarized in GD vide Siliguri PS GDE No- 409 dated 08.06.2022. Subsequently, after sharing the information with I/C Siliguri PS and as per his direction, I along with ASI Siben Sarkar, ASI- Rabin Lama, C/260 Sukundu Roy, C/1048 Gopal Roy, CV/283 Prasenjit Dey, CV/622 Ramanath. Barman left for the place to work out the information. At about 01.05 hrs after reaching Jalpaimore, I met my source and being pointed by the source we started walking towards **Siliguri Trading Corporation Indian oil**. After reaching **Siliguri Trading Corporation Indian oil, Burdwan road** started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted four (04) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Khalpara area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also, supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Khalpara area. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Nandu Turkey (23yrs) S/o- Sahuroy Turkey of Chittaranjan Colony, Bagrakote, W/no- 20, PS- Siliguri, Dist- Darjeeling, (ii) Mukesh Mahato @ Muksha (26yrs) S/o- Lt. Kailash Mahanto of Tikiapara, Majdoor Colony, W/no- 28, PS- Siliguri, Dist- Darjeeling, (ii) Santo Das @ Guddu (22yrs) S/o- Jhantu Das of Ghugumali near Falbazar, W/no- 37, PS- Bhaktinagar, Dist- Jalpaiguri, (iv) Md. Abdul (20yrs) S/o- Moti Mahalla of Dangipara, W/no- 06, PS- Siliguri Dist- Darjeeling and others and arrange for its investigation.
