I, Sri Suman Sarkar, S/O- Late Sunil Kumar sarkar Assistant Engineer & Station Manager, WBSEDCL, Siliguri Town CCC under P.S. Siliguri empowered by the Electricity Act 2003 (Amendment Act 2007) do hereby lodged this complaint against Krishna Prasad, Babita Electricals, Alu Patty, H.C. Road for committing unauthorized use of electricity U/S 135 1(a) & 138 1(b) of the Electricity Act read with Amendment Act 2007 as stated here under.

On 20.04.2022 I Sri Suman sarkar along Pranab Sikhder SO (S & LP), Rabi Chettri, Hg. Gr. Sr. LM. Siliguri Town CCC Conducted one surprise checking at Shop at Babita Electricals, Alu Patty, H.C. Road, siliguri on 08.06.2022 at about 03.00 P.M.

During inspection theft of electricity was detected U/S 135 1 (a) & 138 1(b). The Present user Krishna Prasad, Babita Electricals, Alu Patty, H.C. Road was using electric power from deemed meter no L388382 (Physically L399382) which has given in the name of Krishna Prasad. Details process of theft is enclosed with INSPECTION report.

As theft of Electricity was detected during inspection in our presence, the inspecting team seized the above mention meter in presence of Pranab Sikhder SO (S & LP), Rabi Chettri, Hg. Gr. Sr. LM. Siliguri Town CCC and taken it in my custody in presence of witness. Sri Krishna Prasad has refused to sign on the seizure list and inspection report.

Therefore, I along with my team left the premises after giving the all paper to the beside shop.

The accused person noted above committed offence u/s 135 1(a) & 138 1(b) Electricity Act 2003 and amendment Act 2007.

So you are hereby requested to take necessary action.
