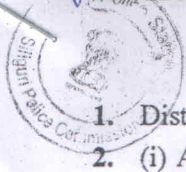

On 08.06.2022 at about 02:00 PM , Sri Suman sarkar along Pranab Sikhder SO (S & LP) , Sri Sourav Bhattacharya ,Sr. O.E. ,Rabi Chettri ,Hg. Gr. Sr. LM Siliguri Town CCC Conducted one surprise checking premises at C/O Everest Corner, behind Broadway Hotel, Bidhan market, Siliguri

During inspection theft of electricity was detected U/S 135 1 (e). The accused person Ram Kumar Agarwala was using electric power for commercial purpose ( Shop) from LT service Meter No P1926246 which is given for residential purpose in the name of Ram Kumar Agarwala. (Details process of theft is enclosed with INSPECTION report).

As theft of Electricity was detected during inspection in our presence and also presence of Ram Kumar Agarwala, bearing meter serial number P1926246 and Inspection team requested to Ram Kumar Agarwala who has been presence of the place of occurrence to become seizure witness. So I seized the above meter in presenting seizure list in presence of Pranab Sikhder SO (S & LP) , Sri Sourav Bhattacharya ,Sr. O.E. Rabi Chettri ,Hg. Gr.
