In producing herewith one arrested person namely Babla Das(40yrs), s/o- Lt. Suresh Chandra Das of Timulpara, near Sankar Sweets, ward No- 04 PS- Siliguri, Dist- Darjeeling along with 11(Eleven) bottles of Himalaya Gold 60up Country spirit each bottles containing 600 ML. & MRP Rs 120/- each bottle Total RS. 1320/- Only.

I PSI Phurba Tendu Sherpa of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 10.06.2022 at 18.45 hrs received an information that one person is busy sailing liquors at his House at Timulpara, near Sankar Sweets, ward No- 04 PS- Siliguri, Dist- Darjeeling for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO – 268 Dated-10.06.2022. As per information I inform to O/C Khalpara TOP under Siliguri PS and as per his kind direction myself along with force proceeded to the PO to work out the information. At 19.05 hrs. we reached at Timulpara, near Sankar Sweets, ward No- 04 PS- Siliguri, Dist- Darjeeling some times after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in open market for his wrong full gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizer list and with level and took signature of the accused person on one bottles taken as sample .The seizure was made in between 19.35hrs to 19.45hrs. I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.


