Sir,

I, ASI Dipak Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate, do hereby lodged this written complaint against one Apu Debnath (45 yrs) S/o Sushil Debnath of P/A Bhagni, Part-I, P.O+PS- Dinhata, Dist- Cooch Behar, A/P Shibrampally, Haidarpara, PS-Bhaktinagar, Dist. Jalpaiguri under arrest along with following seized articles:-

1. 06 (Six) bottles of Budweiser Magnum Beer (each bottle containing 650 ml.)
2. 06 (Six) bottles of Himalayan Gold Country Spirit (each bottle containing 600 ml.)
3. 02 (Two) bottles of Imperial Blue Classic grain whisky(each bottle containing 750 ml.)

In this regard, I beg to report that on 10/06/22 at about 21.25 hrs. myself along with force were engaged on mobile van duty at PS area and received information that one person who carrying huge illicit liquor near Cosmos Mall under Bhakti Nagar for selling to the local customers for illegal gain. As soon as after receiving the information I informed the matter to I/C Bhaktinagar PS and as per his kind order and instruction I conducted raid near Cosmos Mall under Bhakti Nagar PS and apprehended one person namely Apu Debnath (45 yrs) S/o Sushil Debnath of P/A Bhagni, Part-I, P.O+PS- Dinhata, Dist- Cooch Behar, A/P Shibrampally, Haidarpara, PS-Bhaktinagar, Dist. Jalpaiguri and seized the above noted articles from his possession. During raid I found that the above noted arrested accused is possessing the above noted articles and selling it to the customers since long for wrongful gain. Accordingly, I seized the above noted articles in presence of witnesses, I demanded him the papers or license, cash memo of the said liquor but he failed to produce any documents in support of possession of above noted illicit liquor. On interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and selling the same illegally to the people. Accordingly I seized the same after preparing proper seizure list duly signed by the witnesses and accused. Then, I arrested him U/S 41 Cr.P.C. The articles was seized in between 22.20 hrs to 22.50 hrs.

Therefore I pray before your honour that a specific case may kindly be started against accused namely Apu Debnath (45 yrs) S/o Sushil Debnath of P/A Bhagni, Part-I, P.O+PS- Dinhata, Dist- Cooch Behar, A/P Shibrampally, Haidarpara, PS-Bhaktinagar, Dist. Jalpaiguri as per proper section of law.
