Sir,


This is for your kind information that an unforeseen incident took place in the afternoon of 09.06.2022 in the office premises of Block Inspector office Matigara located within B.D.O office premises of Matigara Block. It so happened that Sri Sukumar Barman by force entered the office during office hours when myself and my staff was busy working. The person mentioned came into the office and at about 1:00 pm and forcibly started shutting down the doors and tampered with some official papers throwing them down and as one of our employee protested, he was badly pushed aside by Sukumar Barman. When he was asked the reason for such insolent behaviour he mentioned that he was being forced to discontinue the services of temporary D.E.O from the concerned Block without any prior notice. He continued to hamper the regular work of the establishment for almost two hours and then he left.

Hence, the undersigned wants to lodge a complaint against Sri. Sukumar Barman for tampering with the official papers, forcing entry into the office and creating problems in the smooth working of the office to render public services which is a most important part of our job.

Kindly take action against him so that no further nuisances may be created by him in the future as this sort of behaviour in Govt. office premises is a serious offence.
