Sir,

In producing herewith 1] 15(Fifteen) sealed bottles of Himalayan Gold 60 UP Country Spirit, each bottle containing 600 ml, Total 09 liters, value Rs.120X15=Rs1800/-), and marked as 'Exhibit -A' and 2] 01 (one)sealed bottle of Himalayan Gold 60 UP Country Spirit containing 600 ml, taken from "Exhibit-A" as sample for examination and marked as "Exhibit-A-1"

I, ASI Tapan Das presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against one female person namely Manju Roy(58), W/O- Sailen Roy of Ranabusty, PO+PS- Matigara, Dist- Darjeeling to the effect that today (10.06.2022) at 19.25hrs onwards while performing special drive duty, received a specific source input that one lady namely Manju Roy(58), W/O- Sailen Roy of Ranabusty, PO+PS- Matigara, Dist- Darjeeling illegally selling liquor to the common customers without any valid license for her wrongful gain. Subsequently, myself along with, others force, lady force and officers had been to Rana busty under Matigara PS area and held a raid at the house of Manju Roy but seeing the police party the lady namely Manju Roy as well as the common customers who were taking liquor fled away from the spot. Accordingly, I searched the house in presence of available witness and recovered total 15( Fifteen) sealed bottles of Himalayan Gold 60 UP Country Spirit, each bottle containing 600 ml, which were kept inside a bag found in the house of Manju Roy. Subsequently, being enquired it is revealed from the neighbor that the aforesaid lady Manju Roy had been selling illegal liquor since 06 (six) months. Accordingly, I seized the recovered 15(Fifteen) sealed bottles of Himalayan Gold 60 UP Country Spirit, each bottle containing 600 ml, Total 7.2 liters, value Rs.120X15=Rs1800/-), and marked as 'Exhibit -A' and also extracted 01 (one)sealed bottle of Himalayan Gold 60 UP Country Spirit containing 600 ml, from "Exhibit-A" as sample for examination and marked as "Exhibit-A-1" in presence of available witness. The seizure has been made in between 19.55 hrs. to 20.25 hrs.

Therefore, I pray before your good self that a specific case against the above noted accused person named Manju Roy(58), W/O- Sailen Roy of Ranabusty, PO+PS- Matigara, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.


