Respected Sir / Madam,

I Rinki Khatoon, W/o. MD. Ajmat, D/o. MD. Sabejan, R/o. Swami Nagar colony, Siliguri M.corp., ward no.07, P.S. Siliguri, Dist. Darjeeling, Pin Code. 734005 would like to inform you that on 01/04/2019 one Muslim marriage was solemnized between me and a person namely 1. MD. Ajmat, S/o. MD. Jamir, R/o. Swami Nagar colony, Siliguri M.corp., ward no.07, P.S. Siliguri, Dist. Darjeeling, Pin Code. 734005 as per Muslim rites and customs at my Parental house and subsequently, the aforesaid marriage was also registered under the Muslim Marriage Registrar and Kazi and during the aforesaid marriage as per demand of my above named Husband and his family members namely 2. MD. Jamir, S/o, Not known ( Father-In-Law ), 3. Sajda Begum, W/o. MD. Jamir ( Mother-In-Law ), both of them are residing at Swami Nagar colony, Siliguri M.corp., ward no.07, P.S. Siliguri, Dist. Darjeeling, Pin Code. 734005, 4. Tamana Khatoon, D/o. MD. Jamir ( Sister-In-Law ), 5. Nagma Khatoon, D/o. MD. Jamir ( Sister-In-Law ), both of them are residing at Quareshi Mohulla, Siliguri M.corp., ward no.06, P.S. Siliguri, Dist. Darjeeling, Pin Code. 734005, my parents gave them some gold items like Two Gold Chain, Two pair of Ear Ring, Finger Ring, One Necklace, one Toto rickshaw etc. and other households articles such as T.V., Dressing Table, Alna, Khat, etc. and after the aforesaid marriage I started to live with the above noted person as a Husband and wife at my above noted matrimonial House and during that time my above noted Father and Mother in laws also reside with us as a Joint family. It is pertinent to mention here that after few days of marriage I noticed that my above named husband came to home at late night with drunked condition and after coming to home he after making some criminal conspiracy with my above named Father and Mother in laws they all of them started to tortured upon me by way of Physically and mentally and also my husband including his parents created pressure upon me and demanded a sum of Rs.1,00,000/- ( Rupees One Lacs ) Only and told me that to bring the aforesaid amount from my parents and when I denied to do the same or bring the same at that time my husband and his parents above noted became more ferocious and started to assaulted me with fist and blows but I tried to tolerate all those in-human torture of my husband and his parents with a hope in my mind that one day my husband and his parents changed their behavior in respect of me but such day never come into my life. It is also right place to mention here that I also intimated aforesaid incidents to my above named sister-in-laws and after intimated the aforesaid incidents they told me that they come to my matrimonial house and solve the matter and as per their said assurance they come to my matrimonial house but all are in vain because my sister-in-laws after coming my matrimonial house they also make criminal conspiracy with my husband and his above named parents and during that time they all of them demanded the aforesaid amount from me and when I stated that my father is unable to fulfill their demands at that time they all of them became ferocious and

started to assaulted me with fist and blows and during that time my sister-in-laws threatened me with dire consequences and told me that they will come again and give me a lesson and during that period out of the aforesaid wedlock one female child was born on 22/12/2019 namely, Zainab Parween.

It is important to mention here that on 01/04/2020 my above noted sister-in-laws came to my matrimonial house at evening and on the same day my husband came to home with drunked condition at late night and during that time my sister-in-laws as well as my father and mother in laws also presents at the house and my husband after coming to home he and along with my above noted all in-laws once again demanded the aforesaid amount and when I refused to bring the same from my parents at that time they all of them make some criminal conspiracy and intentionally took KEROSENE OIL from the kitchen and poured the same on my whole body and intentionally they tried to kill me by the aforesaid way but with the mercy of god I some-how tried to fled away from the said spot and took shelter at my parental house and thereafter with the intervention of my father and local councilor several meetings was held and during that time my husband and my in-laws told me in presence of local councilor that they will never implicated any kind of torture upon me after that as per their assurance I once again went to my matrimonial house and started our conjugal life but all are in vain because this time also I noticed that there was no improvements in their behavior towards me but I tolerated all those torture of my husband and my all in-laws with a hope that one day they will changed their behavior in respect of me but such days never came into my life and it is also right place to mention here that during this period I became 2 ( Two ) months pregnant and this time also my husband and all in-laws tortured upon me by way of not providing me proper food and medical care and on 15/02/2022 my sister-in-laws came to my matrimonial house at evening and after coming to my matrimonial house they started to making some criminal conspiracy with my husband and their parents and on the same day at about 11.00 P.M. my above named husband and all in-laws came to my bed room and started to assaulted me with fist and blows and forcefully without my consent they put one PIL tablet on my mouth and for that reasons my pregnancy was miscarriage and I sustained very badly pain on my lower portion and thereafter some-how I contact with my parents and my parents came to my matrimonial house visited with me and thereafter I took shelter at my paternal house and due to tortured by them when I left my matrimonial house with my parents at that time they all of them threatened me with dire consequences told me that if I lodged any complaint against them then they will thrown acid on my face and for that reasons I spent my days with in fear till now and right now also the above named persons continuously threatened me on over telephone as well as on road so, no other alternative way today with help of my well-wishers I lodged this written complaint before you against the above noted persons.

Therefore, I request You be pleased to take necessary legal action against the above noted persons and save me from their hands as early as possible.
