

I, **Salma Khatun** W/O Mehboob Ali, resident of Digrabhita, P.O. & P.S. Bagdogra, Dist. Darjeeling, beg to report you that since last 2 months one **Tajinul Islam** S/O Jamshed Ali resident of Digrabhita, P.O. & P.S. Bagdogra, Dist. Darjeeling has been troubling and torturing me. That he has been threatening me with dire consequences and also stating that he will kidnap me. That he calls me and abuses in filthy language.

Sir, three months ago I got married to my husband abovenamed. That when my marriage was finalized with Mehboob Ali the complained person Tajinul Islam showed his desire to marry me but later he and his family backed out as such I got married to Mehboob Ali. Sir, the complained person has forged my photographs and made indecent photos of mine and has been threatening and blackmailing me that he will post it in social media. That he has also threatened that he will kill my husband. That during my stay in Kochubari, Bidhannagar the complained person has 3-4 times tried to kidnap me.

That last week when I had gone to my aunt's house at Naxalbari from where we went to a beauty parlour he came to know about my whereabouts and reached there and forcefully put me in a car and hit me without any rhyme or reason. That he also snatched my gold chain from my neck. That he has also threatened me with dire consequences and have further threatened me that if I report the matter with police then I will have to face dire consequences as they do not fear anyone as they are very powerful in the locality and that no one can do anything to them.

Sir, since last few months I am living my life in constant fear anticipating attack from the complained person. My life has become a living hell. That he has taken photo with pistol and sent it to me and has stated that if I do not return to him then he will kill my entire family.

Sir, the complained person and his family are very dangerous in nature and prior to this also they have many times fought with my family members without any rhyme or reason.

Sir, the complained person is also threatening me that he will kill my husband.

I, therefore, request you to enter my report so that necessary action may be taken against the accused person mentioned above.
