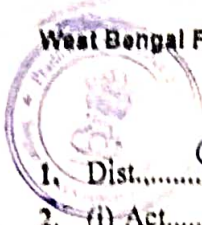

In producing herewith one accused person named Prabhul Mandal(60) S/O- Late Mahabir Mandal of Ambedkar Colony near Sanjoy Math ,P.S- Pradhannagar Dist- Darjeeling, , along with the following seized articles :-

(1) 11(eleven) plastic bottles of Himalayan Gold 60 up country spirit containing 600 ml. each manufacturing by Himalayan Endeavour PVT. Ltd. Siliguri , West Bengal.

I, SI Sibdhan Karmakar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Prabhul Mandal(60) S/O- Late Mahabir Mandal of Ambedkar Colony near Sanjoy Math ,P.S- Pradhannagar Dist- Darjeeling, to the effect that today on 10/06/2022 at 18:55 hrs. In course of patrolling duty received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his hotel name and style as "Prabhuji Hotel" situated at Siliguri Junction Old Matigara road in order to sale the same to his design customers for his wrongful gain. Accordingly the fact is informed to you. As per your direction I along with ASI Tarun kanti Ghosh , CV 223 Swapan Chettri and CV-128 Ajoy Sahani left for Champasari second bridge under Pradhannagar PS to verify the veracity of the information. This referrers to Pradhannagar P.S. G.D.N. No- 643 date 10/06/2022. On reaching there and as identified by source cordoned the "Prabhuji Hotel" situated at Siliguri Junction Old Matigara road with strong reason to believe that he has possessed huge quantity of illegal liquor . On searching found 11(eleven) plastic bottles of Himalayan Gold 60 up country spirit containing 600 ml. each manufacturing by Himalayan Endeavour PVT. Ltd. Siliguri , West Bengal. On being interrogation he could not produce any valid documents in respect of the said illicit liquor.. He also stated that he is doing this liquor business since last 04 months for his wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 19:45 hrs to 20:05 hrs. On being asked he stated that he kept the same with a view to sale and supply at Siliguri Junction area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Person namely Prabhul Mandal(60) S/O- Late Mahabir Mandal of Ambedkar Colony near Sanjoy Math ,P.S- Pradhannagar Dist- Darjeeling, as per proper section of law and arrange it's for investigation .
