I, Aman Gupta son of Santosh Kumar Gupta being one of the member of the trust namely BIG DREAM FOUNDATION , lying and situated at LR Khatian No. 4703 & 4702 corresponding to new L.R. Khatian No. 4927, RS plot No. 773 corresponding to part of L.R. Plot no.1105, situated within Mouza Lalman, JL. No. 96, Touzi No. 91, Pargana Patharghata, PS- Bagdogra, District Darjeeling, do hereby states as follows :-

- 1) That on 11/06/2022, ^{at around 12:15} above named persons along with few unknown persons came to the nursing college lying and situated at LR Khatian No. 4703 & 4702 corresponding to new L.R. Khatian No. 4927, RS plot No. 773 corresponding to part of L.R. Plot no.1105, situated within Mouza Lalman, JL. No. 96, Touzi No. 91, Pargana Patharghata, PS- Bagdogra, District Darjeeling, the culprits are the security on the gate to open the main entrance door which was locked from inside but the security refused to open the gate thereafter some of the culprits scaled the boundary wall and entered the college premises.
- 2) That the culprits were armed with deadly weapon and after entering the college premises they assaulted and over power the security guards on duty and unlocked the main entrance door from inside as a result of which other assailant who were waiting outside entered the college premises.

- 3) That upon entering the college premises they destroyed the CCTV Cameras and went to the ground floor college office where they looted a cash of Rs. 2.5 Lacs which was kept in the Almirah inside the office, thereafter they ransacked the entire office, broke television, destroyed computers consisting of important official documents, and data remove important original document pertaining to the college premises, broke furnitures.
- 4) That the college staff and security guards on duty tried to stop them but they were beaten up, assaulted and was put in a fear of death.
- 5) That the accused person came to the college premises in two separate vehicles one being Maruti Car having registration no. WB74S3669 and another Hyundai Car having commercial registration no. WB73F2647.

Under aforesaid facts and circumstances I therefore request you to take necessary legal action against the aforesaid person namely (1) Sri Kollol Adhikary, son of Hiren Adhikary of Lothamati, J.L. No. 88, P.O. Bhotbari, P.S. Mekhaliganj, District Coochbehar. West Bengal 735304, (2) Sri Amarendra Chakraborty, son of Bidhubhashan Chakraborty of State Farm, Kaloni, Mouja, P.O. Choprajhar, P.S. Islampur, District Uttar Dinajpur 733202, (3) Raisuddin, son of Ab. Kaium of Budhagachh, Durgapur, P.O. and P.S. Islampur, District Uttar Dinajpur, West Bengal 733202, (4) Sri Shyamal Das, son of Late Prīanath Das, of Suiganh, P.O. and P.S.

Chopra, District Uttar Dinajpur 733207, and (5) Sri Promad Thakur, son of Parameshwar Thakur of Puratan Pally, P.O. and P.S.
