i) That one Bainsu Roy @ Bailasu Roy, S/O Lt. Kachu Roy, of Binnaguri, P.O. Fulbari, P.S. Bhaktinagar, Dist. Jalpaiguri, has come to my house at the above referred-to address on 26/08/2019 with his son Mr. Barun Roy (Mob. 9002411492), his close well-wishers namely Roy Da Belaguba (Mob. 8116240620), Mr. Kiran Roy, S/O Topla Roy, of Changrabandha, Fulbari Hat, Dist. Jalpaiguri and 4/5 others also whose names are not known, entered into a Sale Agreement with me on 26/08/2019 for the below scheduled land (the Xerox copies of the same are enclosed herewith).

No. 046825 Dt. 02/07/2019 in favour of Sri Barun Roy, S/O Sri Bainsu Roy @ Bailasu-Roy, for Rs. 2,30,000/- (Rupees two lac thirty thousand) only vide Ch. No. 46291 - C.B. Dt. 26-08-2019 and for 2,20,000/- (Rupees two lac twenty thousand) only vide Ch. No.
