Sir,

I beg leave to Lodge an FIR on the information as hereinbelow.

- 1.That forced by circumstances, I along with my little daughter (approx. 4 year 6 month aged) reside with my elderly parents finally from 27.4.2022 at their flat. Their flat named Shakti-2, Surya Sen Colony, Block-B, Ward No. 34, P.O. Bhaktinagar Dist. Jalpaiguri, Pin-734007 under your police station.
- 2. That I was married to Ashim Chatterjee Biswas of Lanka, Assam on 15th December 2015.
- 3. That marriage was solemnize d according to Hindu Rites, Rituals and customs after observing all the formalities of Hindu marriage Act, at BIKASH BHAWAN, Bhaktinagar (Near Central Bank). Siliguri. Pin. 734004.
- 4. That subsequently the marriage was registered on 9<sup>th</sup> February 2016 under the Hindu Marriage Act 1955.in the office of the Ex- officeo Marriage officer, Bhaktinagar and Malbazar P.S. Area. Vill- Belakoba. P.O.Prasanna Nagar P.S. Rajgang Dt. Jalpaiguri. Pin.735133 W.B. India.
- 5. That irresponsible behaviour and cruelty of my husband and parents-in-law forced me to return to my parents who suffer from age related ailments which got aggravated because of my dysfunctional marriage.
- 6. That it was a negotiated marriage, and the negotiation was vitiated ab initio as the proposer who was the maternal uncle of the bridegroom spun a fiction that the groom was an employee of Siemens Company in Kolkata and he lived in Kolkata. The fiction apart, the fact that the groom was a habitual drunkard that ultimately led to his having Clrrhosis of the Liver was carefully kept hidden from our family.
- 7. That I found on the days following the Boubhat that my husband was a habitual drunkard as he came home inebriated every evening.

That the Boubhat was held at Shanti Villa, N-Area, Sukanta Road, Ward No-2, Near ister Nivedita School, P.O. & P.S. Lanka, Dist-Hojai, Assam, Pin-782446, the parental louse of my husband.

- That I saw that my husband consumed liquor even in the presence of his parents who feigned ignorance.
- 10. That a few days after the marriage we came to live in the family flat of my husband at Sri Durga Residence, Ganesh Pally, Near Lovely Guest House, Lal Ganesh, Guwahati, Assam, Pin-781034 and he could not but reveal to me that he had been jobless since long before the negotiation for the marriage was initiated.
- 11. That my husband, in his state of inebriation, regularly harasses me psychologically be it in Lanka, Guwahati or in Siliguri, his parents being complicit.
- 12. That in the house of my parents in Siliguri, my husband and his parents on several occasions together or severally insulted me and my parents.
- 13. That despite repeated pledge to mend his ways, my husband has not changed even for the sake of our little daughter.
- 14. That the actions and behaviour of my husband and parents-in-law which are contrary to the standard practice that hold together a family and guarantees a blissful conjugal life have forced me to live away from them.
- 15. That yet they continue to annoy me and my parents which constitutes harassment and cruelty.
- 16. That it is impossible for me to go to Lanka or Guwahati to seek legal remedy, and the fact that the cause of action has arisen also at Shakti-2, Surya Sen Colony, Block-B Ward No. 34, P.O. Bhaktinagar Dist.Jalpaiguri, Pin-734007 under your police station, I would like to file this FIR at your police station.
