In producing herewith one accused person namely Jiten Roy (48yrs) Male S/o. Dundi Roy of Bhola More, PO. Sahudangi Hat, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 15(Fifteen) Sealed Bottles of Himalayan Gold Pet. 60 up County spirit Containing 600 ML each.
2. 08 (Eight) Sealed Bottles of Officer Choice Deluxe Whiskey containing 180 ML each.
3. One Nylon Bag which was used to store and carry the said liquor.

I, ASI. Rabi Tamang of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today i.e. on 10.06.2022 at 17:25 hrs while myself along with force left for Evening raid Duty Vide Ambari-Falakata OP GDE No. 348 Dated: 10.06.2022 in course of raid duty I received an information from my source that one person is carrying huge amount of liquor from Nawapara to Sahudangi which he has procured illegally for selling the same in the customer for his wrongful gain. Accordingly I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, ASI. Sailendra Singh, C/876 Ram Chandra Oroan, NVF-108 Swadesh Roy NVF/043 Ranjan Das and VP-014 Paritosh Roy all of Ambari - Falakata OP, Under NJP - PS, SPC proceed to Sahudangi More to work out the information. At about 17:55 hrs we reached at the spot, sometimes after being identified by the source our police party has apprehend one person who was carrying a some material in a nylon bag. During search I have recovered the following articles:- (1) 15(Fifteen) Sealed Bottles of Himalayan Gold Pet. 60 up County spirit Containing 600 ML each. (2) 08 (Eight) Sealed Bottles of Officer Choice Deluxe Whiskey containing 180 ML each (3) One Nylon Bag which was used to store and carry the said liquor. On demand he could not produce any valid license/documents in support of said liquor. He become a nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I have seized the above said articles under proper seizure list and took signature in presence of witnesses namely (1) Subash Sarkar S/o. Lt. Narayan Sarkar of 09 No. Colony, Ambari-PO. Kamarvita, PS. NJP, Dist - Jalpaiguri and (2) Abhijit Majunder S/o. Lt. Ashim Majunder of Ambari-Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri. The seizure was made between 18:15 hrs to 18:25 hrs. And I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Jiten Roy (48yrs) Male S/o. Dundi Roy of Bhola More, PO. Sahudangi Hat, PS-NJP, Dist- Jalpaiguri under proper section of law.
