Sir,

In producing herewith one accused person namely- Gouranga Sarkar (58) s/o Lt. Jai Hari Sarkar of Netaji More, PS- NJP, Dist.- Jalpaiguri along with seized articles viz.,

1] Total 15 (Fifteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 09 liters, value Rs.120X09=1080/-) and marked as Exhibit A.

I, PSI-Pradeep Diyali of New Jalpaiguri PS, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person that today (10.06.2022) at 20.15hrs. acting on source information, myself along with ASI Sajal Das, CV/306 Biswajit Roy and CV/824 Niru Kr Yadab all of New Jalpaiguri PS, Siliguri Police Commissionerate had been to Netaji More, PS- NJP, Dist.- Jalpaiguri. This refer New Jalpaiguri PS GDE No.- 516 date: 10.06.2022. Myself Along with force arrived at Netaji More and held raid at the house of above noted accused person and found that the aforesaid person had been selling illegal liquor to the common customers at his house at Netaji More, Ward No.- 35, PS- NJP, Dist.- Jalpaiguri. Then I cordoned the place with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he used to sell illegal liquor at this place for his wrongful gain since very long. On being search of him in presence of available witnesses the above noted seized articles are found inside a bag from his conscious possession. On being asked he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. While on the time of cordoning off the place, the persons who were having liquor at that place manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 2115 hrs to 2205 hrs.

Therefore, I pray before your good self that a specific case against the above noted accused person namely Gouranga Sarkar (58) s/o Lt. Jai Hari Sarkar of Netaji More, PS- NJP, Dist.- Jalpaiguri may kindly be initiated under proper section of law and may cause for its investigation.
