

Sir,

I. Smt. Sarbari Basu, w/o Sri Biplab Basu, r/o 'BASUSHREE', Satyen Bose Road, P.O. - Kadamtala, P.S. - Matigara, Dist - Darjeeling, PIN - 734011 would like to inform you that my marriage with my husband was held on 27/04/1997. Since marriage we had been living together as husband and wife in my above stated address along with other in-laws including my parents - in - law, brothers - in - law and sisters - in - law. It is to be mentioned that my marriage was negotiated through Smt. Sumita Basu (Bula) w/o Sri Partha Sarathi Basu, who is my sister - in - law, now resident of C/O Benu Ghosh, Deshbandhupara, Near Pathgodam, APC Road, P.O. - Siliguri Town, P.S. - Siliguri, Dist - Darjeeling, PIN -- 734004, who took the main role in my marriage. Unfortunately, since after marriage while living at my in - laws house I was subjected to physical and mental torture at the instance of my father - in - law and others including my husband Biplab Basu for which on my complaint a case was registered against them. However, since after that also my husband continued to subject me to inhuman torture and cruelty and left me after the demise of my mother - in - law in whose name my said matrimonial house was standing. My husband and said Sumita Basu, w/o Partha Sarathi Basu started to conspire against me to drive me out of my matrimonial home in which my other in-laws also took the role to evict me from there and so I filed a case under the Protection of Women from Domestic Violence Act, 2005 and a restrain order was passed against them from evicting me from my matrimonial house along with other reliefs towards my maintenance and others but they did not comply with the said order. After final disposal of the said case, the Ld. Court also passed order directing to pay the maintenance and for separate alternative residence for me. But, still they did not comply the said order.

However, I preferred an appeal before the Ld. A.D.J. (Fast Tract Court), at Siliguri so that my right to residence at my in-laws house may not be interfered with by them and the

Ld. Court passed an order of stay against demolition of the said building which my in-laws along with others attempted to make in the month of April, 2022 in order to evict me.

Further, to mention that my husband still continued to conspire against me and subjected me to mental torture in which Sumita Basu is taking an active role to support and shelter him from her above mentioned address. Even, she arranged the marriage of my husband with one Jayanti Basu (Singha) of Kalam Jote, Durga Mandir C/O- Khemni Singha near Medical Hospital and my husband married her illegally during the subsistence of his marriage with me. Now said Sumita Basu is also sheltering my husband and the said second wife of him at her residence and threatening me if I take any action against them.

Accordingly, said Sumita Basu (Bula) w/o Partha Sarathi Basu, my husband ab Basu and Jayanti Basu (Singha) and some of their associates who attended the second marriage are continuously threatening me if I dare to claim my right to residence as the legally wedded wife of Biplab Basu. I am facing inhuman mental cruelty and torture as well as hardship to be deprived of my legal status as wife and the right to residence of the house. Even my life may be in danger by the acts of Sumita Basu (Bula) w/o Partha Sarathi Basu, my husband Biplab Basu and Jayanti Basu (Singha) and some of their associates. My husband **Biplab Basu**, his second wife **Jayanti Basu (Singha)** along with **Sumita Basu (Bula)** and others by their such acts have committed the offences of criminal intimidation, marrying again during my lifetime and causing and subjecting me to cruelty.

I, therefore would like to request you to take appropriate action against the above named persons for the offences committed by them.
