
Dear Sir,

In connection to the above reference this is to inform you that 01 nos of Substation Structure made of 2 nos 12.8 MTR Rail pole along with 100 KVA Transformer and fittings) has been damaged and broken by a vehicle No: WB39B0764 at about 10.55 P.M on 11/06/2022 near West Point School ,P.S. Matigara, Dist. Darjeeling. Therefore this complain is lodged by the undersigned as per Section 133 of The Electricity Act 2003 for negligently breaking and damaging material of supply of electricity. Due to this accident power failure at the adjacent area was interrupted. After rectification of damaged work power will be restored.

Therefore this letter is placed before you for intimation of the incident and necessary action towards treating this letter as F.I.R.
