Sir,

In producing here with the one arrested accused person namely Nirmal Biswakarma S/O- Lt Limby Biswakarma of Toribari Dabgram-I, PS- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list.

- (i) 12 (Twelve ) bottle of kingfisher Premium Beer (each bottle containing 650 ml)
- (ii) 06 (Six) Bottles of Himalayan Gold 60up Country Spirit (each Bottle containing 600ml)

I, ASI Nitai Mandal of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 03.06.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No.131 Dated. 03.06.2022 at about 14.30 Hrs I, received source information that the above noted accused person have possessed huge amount of Liquor carrying for the purpose of selling at Salugara Road near Lemon tree Hotel under Bhaktinagar PS. Accordingly the information shared before you and as per your kind direction I along with ASI Dipak Karmakar C/986 Rajb Sarkar CVF/014 Labannomay Barman headed towards Salugara Road near Lemon tree Hotel to verify the veracity of the information. We reached at Salugara Road near Lemon tree Hotel as shown and being identified by the source held raid and apprehended one person who disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched him and recovered huge amount of above noted seized liquor from his possession. On demand he could not produce any valid documents/licence in respect of the recovered liquors. On enquiry the apprehended persons admitted his guilt and confessed that he has possessed above noted liquor at Salugara Road near Lemon tree Hotel for the purpose of selling to his designed customers. He also stated that he has been doing this illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 14.55 Hrs to 15.35 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising his ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Nirmal Biswakarma (M/34) S/O- Lt Limby Biswakarma of Toribari Dabgram-I, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
