Sir,

In producing here with the one arrested accused person namely Binod Paswan (M/42) S/O- Lt Debu Paswan of Bedgara Dabgram-I, PS- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

- (I) 12 (Twelve) bottle of kingfisher Premium Beer (each bottle containing 650 ml)
- (II) 05(Five) Bottles of Himalayan Gold 60up Country Spirit (each Bottle containing 600ml)

I, SI Binod Singh Rawat of Bhaktinagar PS under Silliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 03.06.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No.131 Dated. 03.06.2022 at about 14.30 Hrs I, received a source information that the above noted accused person have possessed huge quantity of Liquor carrying for the purpose of selling at Don Boxo More Sevok Road under Bhaktinagar PS. Accordingly I shared the information to I/C Bhaktinagar P.S/SPC as per his direction I, along with ASI Dipak Karmakar C/986 Rajib Sarkar, CVF/014 Labannomay Barman headed towards Don Boxo More Sevok Road to verify the veracity of the information. We reached at Don Boxo More Sevok Road as shown and being identified by the source held raid and apprehended one person who disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched him and recovered above noted seized liquor from his possession. On demand he filed to produce any valid documents/licence in respect of the recovered liquors. On interrogation the apprehended persons admitted his guilt and confessed that he has possessed above noted liquor at Don Boxo More Sevok Road for the purpose of selling to his designed customers for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made in between 14.55 Hrs to 15.35 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the accused person namely Binod Paswan u/s 41 Cr.P.C appraising his ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Binod Paswan (M/42) S/O- Lt Debu Paswan of Bedgara Dabgram-I, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
