I, Suman Sengupta, Son of Ashoke Sengupta, A.E & SM Power House CCC, empowered by The Indian Electricity Act 2003 amended on 2007 do here by lodge this complain for breakage of Electric Poles & Damage of Property of WBSEDCL at Prakash Nagar Limbu Basti, near Parijat sporting club, by unknown vehicle, as reported by local people of the area present at the time of the incident. Yesterday at around 22.00 hrs a report was received by the undersigned regarding a vehicle damaging Electric Pole over telephone. The LT Mobile maintenance van of PHCCC was sent to site and the report was confirmed by the workers of the Maintenance van. It was found that One Electric Pole was damaged causing a Financial Loss Of WBSEDCL of around Rs 13924 (Rupee Thirteen Thousand Nine Hundred And Twenty Four Only).

Thus you are requested to kindly initiate an investigation & book the culprit under Section 139 of the Indian Electricity act 2003 amended on 2007.
