Sir,

I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one arrested accused person namely Uttam Thapa (44) s/o Budhe Thapa of Lalitnagar PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Twenty three (23) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1.
2. Ten (10) sealed Bottles of Kingfisher Strong Premium beer, each bottle 650 ml each Marked as exhibit -B in which 01 bottle taken as sample for examination exhibit-B1.

I am submitting a written complaint against the above noted accused person to the effect that today 10.06.22 at 17-45 hrs received secrete source of information that one person was selling Liquor illegally from his shop cum house at Lalitnagar to its customers without any valid license. Accordingly the duty officer of Bagdogra PS informed the matter to O.C. Bagdogra PS and as per his instruction myself along with ASI Khagen Barman and C/1008 Kanak Roy, CV- 386 Kishor Hawlder CV- 389 Janak Singh, VP- 02 Pradip Roy left for Lalitnagar to verify the veracity of information which noted in GD vide Bagdogra PS GDE No. 533 dt. 10.06.22. On arrival at the spot at 18-15 hrs it was found that one person mention above was selling liquor illegally from his shop cum house to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, On being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses namely (1) C/1008 Kanak Roy and (2) CV- 389 Janak Singh I with the help of others police personnel searched and recovered (1) Twenty three (23) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 650 ml (2) Ten (10) sealed Bottles of Kingfisher Strong Premium beer, each bottle 650 ml which was kept in his shop and seized the same as per proper seizure List from the possession of the apprehended person and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 18-35 hrs and 19-45 hrs (seizure Total 20.3 Lts).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Uttam Thapa (44) s/o Budhe Thapa of Lalitnagar PS Bagdogra Dist. Darjeeling and arrange for its investigation.
