Sir,

I Amullya Tarafader S/O.Lt. Haren Trafader residing at Sitagauri ,P.O.Mahanvita, P.S.N.J.P., Dist. Jalpaiguri lodged a written complainant to the effect that

- 1.That I purchased land measuring 157 decimals in connection with R.S. Khatian no.52,Sheet No.2, Plot No R.S.914,corresponding L.R. Plot No. 914 situated under Mouza- Mehendi Gochh, P.S Rajganj(Old), Bhaktinagar(Second New), N.J.P.(Presently), Dist Jalpaiguri with valuable consideration by way of three sale deeds no. I 952 YEAR 2017, I 1794 year 2017 & I 1795 YEAR 2017 from Subhajit Rakshit . Subhajit Rakshit purchased the said land from R.S. Owner namely Kalimuddin Md. legal heirs .
- 2.That the after physical possession my name also recorded L.R. Khatian vide no. 529,530, and possessing the same since long without any interruption from any corner from any point of time within specific boundary.
- 3.That few months some miscreants namely i)Bijoy Sar Kar s/o. Ajit Sarkar, 2.Aisanul Haque s/o.Sanirul Haque, 3.Dhukhiram Das s/o.Arjun Das, 4.Budha Bhowmik s/o.Brojabashi Bhowmik all residing at Sitaguri, P.O.Mahanvita, P.S.N.J.P., Dist. along with their antisocial associates are trying to enter the land and threatened me along with my wife & son with dire consequence .
4. It is pertinent to mention that on several occasion local inhabitants came forward to help us and they somehow restrained from entering the above mentioned land for the time being.
- 5.That the above named persons are the habitual land grabbers of the locality and they in collusion and in connivance with each other, with a malafide and ill- motive of causing loss and injury to us and with an utter intention to grab the land, are regularly moving in and around the land due to heavy escalation of land price and due to commercialization of the entire area, they have perpetrated fraud and on the basis of some fraudulent documents, they have also started making frivolous claim over the land.
- 5.That today at about 10.30 A.M. when I along my son standing the aforesaid land to see the labour work of the land then all on a sudden the aforementioned persons being wrongfully trespass our land with iron rod, sword, lathi & shrieks and started assaulting me and son with lathi & sticks resulting tremendous pain in our bodies when the neighbor peoples came to our land the aforesaid person fled away.
6. That the above mentioned miscreants and their associates are very dangerous and desperate in nature. They do not hesitate to take law in their own hand.
