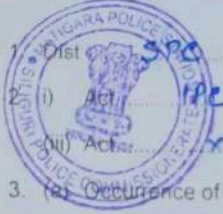

I Manisha Sanjeev Nikam w/o Group Captain SR Nikam, we were coming from Balbari side on new chumta road towards khaprail tank chowk gate. (Suzuki scross - HR 26 CW 6275) ^{around 08:10 PM.} Our car and the other car slowed down at speed brakes opposite to each other. Then they started shouting and giving GALIS and saying our vehicles would have touched. How are you driving the car. My husband said that nothing has happened. What is the problem. They said Ruk abi baste hai and continued giving GALIS. and started opening the door of their car. The place was lonely so my husband drove the car continuously. Then they U turned their car and followed our car continuously honking and shouting. Near the tank chowk gate they suddenly over took the car from left side and blocked the road. So my husband had to stop the car. Two of three of them started hitting came towards us. One of them climbed the car and broke the front shield with his foot. Two of them started hitting my husband on the face who was sitting in the car itself. I tried to tell them please leave him. They were smelling of alcohol. My daughter went and called army personnel from the tank chowk. Around twenty people were gathered at the spot. Some of them tried to talk with ^{them} after the army personnel came they went in the car and drove away. In the mean time vehicle photo was clicked and details of the car are (Maruti Suzuki, No- WB 74 AH 4897). My husband moved to Army polyclinic for treatment.
