Subject: Complaint by Santa Kumar Oraon, S/o Bhadoa Oraon, against the below named persons for social humiliation and for fraudulently and illegally occupying, taking into possession our tribal land located at Mauza Khoplashi.

Respected Sir,

This is to inform you that my deceased father late Bhadowa Oraon, S/o late Sattia Oraon, was gifted all that part and portion of land measuring 1 Acre 70 Decimals located at LR Plot No 436, Mauza Khoplashi, JL No 21, earlier JL No 23, P/S Matigara, Dist Darjeeling, by virtue of a registered Deed of Gift, dated 05/04/1988, executed by one Sri Ravindra Kumar Sahu as lawful and constituted Attorney of Sri Jagadish Prasad, S/o late Harinarayan Prasad, being document No 2638 of 1988, registered at the Office of District Sub Registrar at Siliguri. That my deceased father was the cultivator of the land of Sri Jagadish Prasad and having rendered services of cultivation throughout his lifetime and for such services rendered the said land was donated to my father

That my father died intestate without mutating his name on records in the office of Block Land Reforms Office at Matigara. That after the death of my father and mother, I along with my brothers, (1) Baiju Oraon (since deceased), (2) Ropen Oraon and my sisters (3) Nahiwari Oraon, and (4) Fedo Oraon became legal heirs of our deceased father by virtue of laws of Hindu Succession and had been possessing and enjoying the same without any obstruction.

That my brother late Baiju Oraon expired and my other brother Ropen Oraon has gone missing over the span of more than 20 years, and now presumed to be dead.

In the year 2016-2017, I discovered that my sister in law, Smt Jethini Oraon @ Jetni Oraon. Jetni Oraon in connivance with the below named persons by way of misrepresentation and submission of false documents, presumably duplicate legal heir certificate of my deceased father succeeded in mutating her name on Record of Rights with land appertaining to LR Plot No 436, in LR Khatian No 858 of Mauza Khoplashi, JL No 21, without any intimation or knowledge to us. No notice or intimation of any kind whatsoever was served to us at the time of mutation.

That today the below named persons have completely taken over possession of our inherited land and despite being lawful legal heirs we have been deprived of our property which was lawfully donated to our father.

That being felt deceived and cheated about the hard earned assets of my deceased father, it was taken away by the influential land mafias by hatching a conspiracy towards us. For that we are tribals, poor, economically deprived as non-influential in society, ever since we have been running from pillar to post since the past many years to make our ends meet and retain our lost assets which has gone into wrong hands by misrepresentation and muscle flexing of the following persons. I along with my family members repeatedly requested the below named persons time and again whenever we went tried to visit our land so as to recover possession. But in return every time we were scolded, assaulted and intimidated with derogatory and insulting verbal abuses, unparliamentarily phrases depicting that we are backward tribal people, illiterate and socially discarded society, which utterly humiliated us.

In view of the above, unable to bear any further humiliation and insult meted out to us because of our social standing, it is most respectfully requested that my grievance may be looked into and appropriate action within the ambit of law may be taken against the above accused persons.
