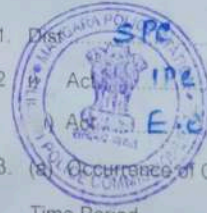

under proper seizure list. I SI Goutam Kundu of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against the owner namely Arindam saha S/O Swapan saha owner of "Ava Hotel" of Shibmandir Bazar near Electricity Office PS Matigara Dist Darjeeling .. Who was illegally procured the domestic Gas cylinder at his Hotel styled as "Ava Hotel" for commercial purpose without any valid documents or licence to the effect that today i.e. 13.06.22 at about 14:00 hrs received an information from reliable source that above noted Hotel Styled as "Ava Hotel" situated at above mentioned address using the domestic Gas cylinder at his Hotel for using commercial purpose for wrongful gain.

Accordingly, the matter informed to ACP EB SPC and as per his direction I, along with, ASI Ashok Biswas C/424 Manik Roy , CV-019 Debendra Nath Roy all of EB SPC with investigation kit left for Matigara PS vide EB SPC M.C.C No 88/22 Dt.13.06.2022. The matter informed to Matigara PS for providing police assistance vide Matigara PS GDE No. 764 dated 13/06/22. At 14'25 hrs myself along with SI Krishna Ch Mondal, C/810 A Minch & Cv-783 Nirodh Singha of van K-33(Matigara PS) vide Matigara PS MCC NO 2097/22 Dated 13/06/2022 had been to Shibmandir Bazar near Electricity Office PS- Matigara, Dist- Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure. As per source information we reached and entered into the Hotel styled as "Ava Hotel" situated at Shibmandir.Bazar near Electricity office , PS- Matigara, Dist- Darjeeling During search found worker of Hotel by using the domestic HP Gas cylinder without any valid documents for commercial Purpose use, On demand they failed to produce any valid documents in support of using the HP domestic gas cylinders in the kitchen of said hotel for commercial purpose. Further local enquiry it revealed that the above noted hotel owner is using the domestic gas cylinder for preparing Food Items at the Hotel for commercial purpose in order to wrongful gain without any valid document. I also invited two independent witnesses namely (1)Bimal Dutta S/O Lt.Narayan Ch Dutta of Bairatisal Jote, Behind NBU , PS MTG Dist- Darjeeling (2) C/424 Manik Roy of Enforcement Branch Siliguri PC .

During local enquiry it could be learnt that the hotel owner namely Arindam Saha s/o .Swapan Saha owner of Ava Hotel at Shibmandir bazar near Electric Office, PS- Matigara .dist Darjeeling using the domestic gas cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles from the possession of his staff namely Bapi Roy S/O Bablu Roy of Netajee Pally Shibmandir PS- Matigara, Dist -Darjeeling. in presence of witnesses after preparing proper seizure list and label .The seizure was made in between 15:05 hrs to 15:35 hrs in the presence of witnesses. But found the owner of Hotel Arindam Saha absconded from the shop to evade police arrest.

Hence, I pray that specific case may kindly be started under section 285 IPC read with section 7(i)(a)(b)(c) of Essential Commodities Act 1955 against the accused person namely Arindam Saha (37) S/O Swapan Saha hotel owner Styled as "Ava Hotel" situated at , Shibmandir Bazar, near Electricity office , PS- Matigara, Dist- Darjeeling and arrange for its investigation.
