

Sir,
In producing herewith one (01) arrested accused person named Prasenjit Roy (20), S/O- Bijoy Roy of Matigara Bazar, PO+PS- Matigara, Dist-Darjeeling (not verified) along with the following articles under seizure as per seizure list Viz;

1. One iron made improvised one shutter Firearm having its trigger, hammer and firing pin measuring approx 10.10 inch including its butt, body and barrel. [The articles have been found kept concealed on the left side of waist of accused Prasenjit Roy and marked as "Exhibit-A".
2. One number of live ammunition inscribed as "8 6", "7" and "OK" which was loaded inside the Exhibit-A and marked as "Exhibit-A1".

I, SI Uday Chakraborty of Matigara Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted one (01) arrested person named Prasenjit Roy to the effect that today on 13.06.2022 at about 18.35 hrs I received a specific source input that one person is standing at Biswas Colony near Railgate under Matigara PS for committing heinous crime. He used to carry and possess small arms & ammunition with him. The matter was diarized vide Matigara PS GDE No. 781, Dt. 13.06.2022. Accordingly, I informed the matter to the Officer-in-Charge, Matigara Police Station. Subsequently, as per his kind direction myself along with PSI Shekhar Adhikary, ASI Tapan Das, ASI Dharendra Nath Mandal, Const- 974 Mintu Sen, C/1053 Poresh Rava all of Matigara PS and along with investigation kit left for Biswas Colony near Railgate under Matigara PS by govt. vehicle to verify the veracity of the information. This refers Matigara PS GDE No. 782, Dt. 13.06.22 and MTG PS MCC No. 2097/2022 Dt. 13.06.2022. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Biswas Colony near Railgate under Matigara PS, I contacted two persons namely (i) Md. Khan (45), S/O- Md. Zahil of Tulsinagar, PO+PS-Matigara, Dist- Darjeeling and (ii) Md. Nurul(33), PO+PS- Matigara, Dist-Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed.

Thereafter, we along with the independent witnesses reached at Biswas Colony near Railgate under Matigara PS at 19.35 hrs and being pointed by my source apprehended the above noted accused person named Prasenjit Roy (20), S/O- Bijoy Roy of Matigara Bazar, PO+PS- Matigara, Dist-Darjeeling and searched him immediately and found the above noted articles from his conscious and exclusive possession. On demand he failed to produce any document in support of his possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused named Prasenjit Roy exclusively & consciously possessed this improvised fire arms loaded with live ammunition illegally with some ill motives.

Thus, his involvement in carrying and possessing illegal fire arm is established. Accordingly, I seized and labeled the above noted articles at the spot under proper seizure list duly signed by Prasenjit Roy as well as by the above noted independent witnesses and also put their signature on the seizure list and label. The whole process of seizure and label has been done in between 20.05 to 21.25 Hrs. I also arrested him preparing memo of arrest after informing ground of his arrest.


From the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused Prasenjit Roy has carried the said fire arms loaded with live ammunitions with an objective to commit heinous crime in the locality.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Prasenjit Roy(20), S/O- Bijoy Roy of Matigara Bazar, PO+PS- Matigara, Dist-Darjeeling (not verified) and arrange for its investigation.
