Mekhliganj, Dist - Coochbhar, west Bengal, Pin . 735301 of the member & also the SETTLER of a Trust namely "DREAM BIG FOUNDATION" registered office situated at Mulai Jote, P.O.- Gossainpur, P.S. Bagdogra, District- Darjeeling, Pin. - 734014 most respectfully beg to state that :-

1) That on 11-06-2022 at about 1 pm ,when I along with others member of the trust namely "DREAM BIG FOUNDATION" were present inside the building premises of the said truest, situated at P.O.- Gossainpur, P.S. Bagdogra, Jote, Received on 13-06-22 Darjeeling, Pin. - 734014 at the relevant time some persons namely 1) Aman Gupta ,S/O- Sri Santosh Kumar Gupta ,Address-SibNath Ghosh, Holding No-237; W/N28 near Merbal Bazer , Siliguri, Dist- Darjeeling 2) Sri Jayanta Chakraborty, residing at Kadamtala, Baramohan singh Jote, PS- Matigara & 3) Mr Ali Imran Ram @ VICTOR (Ex MLA) S/O- Mr Ramzan Ali, R/O- Binardaha, PO & PS-Chakulia, Dist-Uttar Dinajpur along with some other antisocial people forcefully entered inside premises of our said trust property and started to create nuisance& violence without any provocation from our end and threatened to withdraw the case, against the Sourav Chakraborty and against them namely, Sri Jayanta Chakraborty (father of the said Saurav Chakraborty), Mr Ali Imran Ram @ Victor, who are the prime accused of the Bagdogra PS case No 132/2022 Dated-8.3.2022, u/s-406/420/468/471/385/120B of I.P.C, and in response of such when I refused to accept their illegal demand then one of trespasser culprit namely Aman Gupta started to assault upon me and the manager of our said truest by fist and blows not only that but also other accused trespasser namely Sri Jayanta Chakraborty & Ali Imran Ram@ Victor (Ex MLA) were providing instruction to their hired antisocial men to attack on CC TV camera as a result those hired antisocial people attacked on CC TV camara and damaged the same completely, whose market price 100000(one Lac) rupees and said culprits demanded huge amount of money by showing knife towards the members and stuff of our said trust and warned us to immediate vacant the possession of our said trust property in the mean time observing the situation ,some travelers and local people who were passing through the road side started to assemble near the spot, having seen the local people may witness the fact of such incident ,those culprits snatched the money of rupees 1,50000(one lac & fifty thousand ) from the cash box of our said truest office but we could not do anything as those culprits were threaten us with knife and after that they escaped from the spot.

- 2) That it is pertinent to mention here that Said Jayanta Chakraborty and Ali Imran Ram @ Vitor are the main accused of the Bagdogra Ps case No- 132/2022 and they still trying to avoid the arrest and others accused namely Sourav Chakraborty ,S/O- Jayanta Chakraborty has been under judicial custody in connection with the said case not only that but also one title suit No-108/2022 filed against them as such in order to take undue & illegal advantage by dispossessing us (member of the said truest) from the legal possession of the truest property and showing such force as mentioned above they are trying to make us accepted their demands.
  - 3) That the said Aman Gupta, Jayanta Chakraborty & Ali Imran @ Victor along their associates are dangerous in nature and also desperate character and they determent to grab our land and building & they further can harm me & also the other members of our truest "DREAM BIG FOUNDATION" hence I came before you.

It is my humble request before you may kindly take necessary action against such above mentioned culprits to avoid any unfortunate incident which may take place upon us by the illegal act of the said culprits and also praying for help to recovery of the snatched amount of money through due procedure of law. That also sorry to say for the above said incident I was very ill and I was in consultation with my physician for that reason I was unable to submit this FIR on same date.
