Sir,

In producing herewith 03 (Three) arrested accused persons namely (1) Raja Sariswal (36) S/O Sukraj Sariswal of TB Hospital Quarter, Ward No-44, PS - Bhaktinagar, Dist- Jalpaiguri (2) Sourav Dey (40) S/O Late Basu Dey of Haiderpara, Amrit Sweets Goli, PS- Bhaktinagar, Dist- Jalpaiguri A/P 1 No Dabgram, Ward No 23, PS- Siliguri, Dist- Darjeeling (3) Arun Kumar Chowdhury (38) S/O Ram Sagar Chowdhury Biswas of Ashrampara opposite Akash Nursing Home, PS- Siliguri, Dist- Darjeeling along with seized articles (i) one knife measuring 12" including wooden handle wrapped from the possession of Raja Sariswal which was kept concealed on the back side waist (ii) one Hansua (sharp cutting weapon) measuring approx 14" including its wooden handle and one torch light recovered from the possession of Sourav Dey which he was holding on his hand (iii) One iron rod measuring approx 25" pointed one end recovered from the possession of Arun Kumar Chowdhury which was holding on his hand under proper seizure list.

I, SI Ashim Das of Panitanki TOP under Siliguri PS/ SPC do here by lodge this written complaint against the above noted arrested persons to the effect that today on 13.06.22 at 22:15 hrs I received secret source information that 10/12 persons have been assembled beside Mahananda River Bank behind Surya Sen Park to commit dacoity at the locality. Immediately informed the tip of information to O/C Panitanki TOP as well as I/C Siliguri PS and as per their kind direction I diarized the fact in GD book vide Panitanki TOP GDF No 354 dated 13/06/22 and myself along with SI Uday Shankar Mandal, ASI Mantu Dey, C/153 Santosh, C/233 Nagen Ch Barman, C/576 Binay Ch. Barman, CV/1007 Jiten Roy left for Mahananda River Bank behind Surya Sen Park to verify the veracity of the information. This refers Panitanki TOP GDE No- 355 dated 13/06/22 and MCC No- 720/22 dated 13/06/22. At about 22:35 hrs I along with Police party arrived at the spot i.e. beside Mahananda River Bank behind Surya Sen Park and after keeping our vehicle at a distant place we proceeded towards Mahananda River Bank behind Surya Sen Park on foot and being indicated by the source found from the considerable distance that a gang of 10/12 persons were assembled beside Mahananda River Bank behind Surya Sen Park and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase we manage to apprehended 03(Three) persons and taking advantage of darkness others were fled away from the spot. On interrogation, the apprehended persons disclosed their name & address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that, they along with 8/9 persons were assembled there in preparation to commit dacoity. Accordingly, I managed to call two independent witnesses on the spot and on being search in presence of the independent witnesses I recovered (i) one knife measuring 12" including wooden handle wrapped from the possession of Raja Sariswal (36) S/O Sukraj Sariswal (ii) one Hansua (sharp cutting weapon) measuring approx 14" including its wooden handle recovered from the possession of Sourav Dey (40) S/O Late Basu Dey (iii) One iron rod measuring approx 25" pointed one end recovered from the possession of Arun Kumar Chowdhury (38) S/O Ram Sagar Chowdhury. Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and duly singed by them in between 23:45 hrs to 00: 15 hrs and I arrested them U/S 41 Cr.P.C. after explaining the charges against them.

Under the above fact and circumstances I pray that a specific case may kindly be started against (1) Raja Sariswal (36) S/O Sukraj Sariswal of TB Hospital Quarter, Ward No-44, PS - Bhaktinagar, Dist- Jalpaiguri (2) Sourav Dey (40) S/O Late Basu Dey of Haiderpara, Amrit Sweets Goli, PS- Bhaktinagar, Dist- Jalpaiguri A/P 1 No Dabgram, Ward No 23, PS- Siliguri, Dist- Darjeeling (3) Arun Kumar Chowdhury (38) S/O Ram Sagar Chowdhury Biswas of Ashrampara opposite Akash Nursing Home, PS- Siliguri, Dist- Darjeeling and others under proper Section of law.
