1. I lodge this complaint to the effect that on 29th June 2020 I got married to Ankit Mittal Son of Madan Agarwal Mittal Resident of Deokota toll, Jaigaon, Dist- Alipurduar according to Hindu rites and customs.
2. That the said marriage was arranged marriage and at the time of marriage my In-laws namely Sri Madan Agarwal Mittal, Bhama Mittal, Anuj Mittal & Motilal Agarwal demanded a cash dowry of Rs 3,51,000 (three lakh fifty one thousand) at the time of marriage including various articles and household items and golden ornaments by my father and my father agreed to manage and pay them the money and the demanded articles as well as the golden ornaments for my cordial marriage life.
3. That soon after marriage my in-laws started to torture me both mentally and physically and pressurized me to bring more money from my paternal house and when I refused to comply their demands my mother-in-law namely Bhama Mittal , my father-in-law namely Madan Agarwal Mittal, my brother-in-law namely Anuj Mittal all resident of Deokota toll, Jaigaon, Dist- Alipurduar started to torture me both physically and mentally in order to extract money from my father. Hearing about these brutal and inhuman activities and in hope for the peaceful marital life my father again sent Rs.3,00,000/- to my In-Laws.
4. That thereafter my In-Laws as mentioned above always used to humiliate me and taunt me for bringing insufficient dowry. That from the very next day of the marriage I was treated like a servant and was never given the status of Daughter-in-Law in my matrimonial house but still I bore all the tortures with the hope that everything will be alright in future but all went in vain.

5. That meanwhile my uncle in law namely Motilal Agarwal, Son of Bhagwan Das Agarwal, C/O- Bajrangabali Industry, Resident of Madarihat, P.S.- Madarihat, Dist.- Alipurduar used to visit my matrimonial in a frequent manner and always used to provoke my husband alongwith my in laws to extract money and torture me and thereafter use to taunt me and used various filthy languages against my parents.
6. That thereafter due to the aforesaid wedlock one male child was born namely Vansh Mittal on 9th June, 2021. After the birth of my son I thought that everything will be fine but all went in vain.
7. That thereafter when my husband used to go for work and taking undue advantage my in-laws started to increase the torture day by day upon me as well as upon my minor child but I tolerated all the torture with a hope that everything will be alright in future. Moreover after passing of time they started to beat me mercilessly and inhumanly and when I objected the same they threatened me to kill me along with my minor child.
8. That when I used to complain about these tortures over me and my minor child to my husband he used to raise his voice against my In-Laws but they used to threaten him to kill him along with our child or to oust me along with my husband and child from my matrimonial house and my husband used to keep mum as he was helpless and loved respected his parents as well.
9. That thereafter my brother-in-law namely Anuj Mittal who is a drug addict in the absence of my husband used to hold me by my back forcefully with illicit intention and on resistance he used to beat me up mercilessly under the purview of alcohol and when I used to complaint about the said heinous activities to my Father and Mother-in-Laws they rather than teaching their son a lesson used to encourage him and tell him do whatever you feel like until and unless she brings money from her paternal house.
10. That on June 2021 just after the birth of my son when my husband was at work my brother-in-law forcefully tried to enter my bathroom while I was taking bath and when I raised my voice he kicked me hard and abused me in filthy languages when I was not even able to walk properly as because few days back I had a surgery when I gave birth to my son. Meanwhile when I shouted my in-laws along with my uncle-in-law entered the room and on seeing the incident locked me in my room and snatched my phone when I was going through such severe medical issues without providing me food the entire day and when my husband returned from work he unlocked the door of my bedroom.
