Sir,

I, Michael John Sah, son of Late John Florian Sah, aged about 73 years, resident of House No. 18, Himalaya Kanya Abasan, Phase-2, Eastern By Pass Road, Salugara, P.S. – Bhaktinagar, P.O. – Salugara, - 734008 do hereby beg to state the following:

1. That yesterday (14.06.2022) at about 6 P.M. I, accompanied by my son Rajiv Michael Sah, was returning home from evening walk. It was then that a pet dog owned by one of my neighbours Niloy Banerjee chased me. An old man aged 73 years I tried my best to run away from the dog but failed when my said son came to my rescue and chased the dog away.
2. That as the owner of the dog Sri Niloy Banerjee, his wife whose name is not known to me and a friend of theirs saw my son chasing the dog away they got enraged and started beating my son with a stick and umbrella and also bit him on the shoulder. As the said Niloy Banerjee and his wife were assaulting my son brutally their said friend was holding my son tightly so that he cannot move and escape.
3. That as a result of the said brutal assault my said son suffered multiple abrasions on the neck, chest, left forearm, left arm and also teeth bite on the shoulder.
4. That as the pain due to the said injuries became unbearable my son was taken to Siliguri District Hospital at about 10-20 P.M., where he was examined by the attending doctor and was treated. The said doctor advised me to report the incident to the Police station concerned as the Hospital authority noted the incident as 'POLICE CASE'.

Under the circumstances stated above, you are requested to kindly take appropriate legal steps against the said Sri Niloy Banerjee, his wife and his said friend and oblige.
