I am submitting a written complaint against the above noted accased person to the effect that today 17.06.22 at 18-45 hrs received secrete source of information that one person was selling Liquor illegally from his shop named "Raju Hotel" at Gossainpur More to its customers without any valid license. Accordingly the duty officer of Bagdogra PS informed the matter to O.C.
