I, Suman Sengupta, Son of Ashoke Sengupta, A.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complain for breakage of Electric Poles & Damage of Property of WBSEDCL near Sanjivani hospital behind Makhan Bhog, Janata Nagar, P.S Bhaktinagar by vehicle no WB71- A1230 (Ph No- 9932646222), as found on site. Yesterday night at around 01.30 hrs of 17.06.2022, a report was received by the undersigned regarding a vehicle damaging Electric Pole over telephone. The LT Mobile maintenance van of PHCCC was sent to site and the report was confirmed by the workers of the Maintenance van. It was found that One Electric Pole along with other service infrastructure materials was damaged causing a Financial Loss Of WBSEDCL of around Rs 42808/- (Rupee Forty Two Thousand Eight Hundred And Eight Only).

Thus you are requested to kindly initiate an investigation against the owner of the vehicle no WB71- A1230 under Section 139 of the Indian Electricity act 2003 amended on 2007.
