Sir.

In producing herewith three (03) arrested accused persons namely (i) Diwash Chhetri (30) S/O Lal Bahadur Chhetri of Gazing Bazar, PS- Gazing, Dist.- West Sikkim, (ii) Anil Saha (25) S/O Binod Saha of Jyotinagar, P.S- Siliguri, Dist.- Darjeeling and (iii) Bhabtoosh Kumar Roy (24) S/O Bhavani Roy of Moharaj Colony, Ward No. 04, p.s- Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made Crowbar measuring 26 inch (approx) in length from the possession of Diwash Chhetri which was kept on his right hand,
- (2) One iron made sword measuring 30 inch (approx) including wooden handle from the possession of Anil Saha which was kept concealed on his back side
- (3) One iron made 'Katari' measuring 26 inch (approx) including wooden butt from the possession of Bhabtoosh Kumar Roy which was kept concealed on his back side,
- (4) Two Iron rod measuring 40 inch (approx) and 35 inch (approx) in length.

I, PSI Newton Biswas of NJP PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Diwash Chhetri, (ii) Anil Saha, (iii) Bhabtoosh Kumar Roy, and others to the effect that today on 14.06.2022 at 01.15 hrs received a sources information that 10/12 youths have assembled at Gate bazaar, North Colony area under NJP PS with a view to commit dacoity at that area. The fact was diarized in GDE vide NJP PS GDE No- 677 dated 14.06.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with HG/794 Ranjit Roy, VP /08 Laxman Roy, VP/ 13 Jamirul Islam, CV/306 Biswajit Roy and CV/ 116 Rohit Kumar Mahato left for the place to work out the information.

At about 01.35 hrs after reaching near Gate bazaar, North Colony area under NJP P.S I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. But, on hot chase we managed to apprehend above noted three (03) accused persons namely (i) Diwash Chhetri, (ii) Anil Saha, (iii) Bhabtoosh Kumar Roy along with seized articles from their possession as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Lake Town area.
