In producing herewith 03 (Three) arrested accused persons named (1) Chandan Roy (23 Yrs) S/o Parimal Roy Of Farabari-Velkipara, P.o-Sahudangi hat, Ps-NJP, Dist-Jalpaiguri and (2) Gobinda Barman @ Dolo(21) S/o Rabin Barman Of Hatiyadanga, P.o-Sahudangi hat, Ps-NJP, Dist-Jalpaiguri and (3) Bishal Barman (19) S/o Priyanath Barman of Farabari Adarshapally, P.o-Sahudangi, Ps-NJP, Dist-Jalpaiguri along with seized articles (i) One iron-made 'Khukri'(Sharp cutting) recovered from the possession of Chandan Roy (23 Yrs) S/o Parimal Roy Of Farabari-Velkipara, P.o-Sahudangi hat, Ps-NJP, Dist-Jalpaiguri which was kept concealed on the back side of his waist (ii) One Sword (sharp cutting weapon) recovered from the Possession of from the Possession of Bishal Barman (19) S/o Priyanath barman of Farabari Adarshapally P.o-Sahudangi, Ps-NJP, Dist-Jalpaiguri (iii) One iron rod measuring approx 22" pointed one end recovered from the possession of Gobinda Barman @ Dolo(21) S/o Rabir Barman Of Hatiyadanga, P.o-Sahudangi hat, Ps-NJP, Dist-Jalpaiguri which he hold in his hand (iv) One three Cell torch light under proper seizure list.

I, SI Phup Rinchey Bhutia of Ambari-Falakata OP, PS-NJP/SPC, do here by lodge this written complaint to the effect that on 16.06.2022 in course of night Spl. mobile van patrolling duty received secret source information that 10-12 persons had assembled in the bank of Korotowa River at Sitaguri to commit dacoity in the locality. Immediately informed the tip of information to O/C, Ambari-Falakata OP and as per his kind direction myself, C/256 Bibhuti mahato, C/ 975 Swarup Basak, C/505 Tapas Dutta, NVF/068 Amit Roy, VP/014 Paritosh Roy left for Sitaguri to verify the veracity of information. This refers to Amb\_Fkt OP GDE No. 542 dt.16.06.2022. At about 00.51 hrs I along with the police party arrived near Sitaguri Petrol Pump and after keeping our vehicle there we proceeded towards Korotowa River-banks on foot and being indicated by the source found from the considerable distance that a gang of 10-12 persons were assembled behind the bushes at the bank of Korotowa River and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase manage to apprehend three persons and other persons fled away from the spot. On interrogation, they disclosed their name and address as noted above and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that they along with (1) Pradip Roy@Tufan (2) Prasenjit Roy, (3) Ram Binoy Sahani @ Leltu & others assembled there in preparation to commit dacoity. Accordingly, I managed to call two independent witnesses (i) Kanailal Biswas S/o I
