Sir,

In producing herewith one accused person namely Ajit Barman (61 yrs) S/O Late Danda Barman of Santinoy Colony, Biswakarama Mandir, PS- Matigara, Dist.- Darjeeling along with following articles under proper seizure list :-

(i) 17 (Seventeen) sealed bottles of 'Himalayan Gold 60 UP Country Spirit each bottle containing 600 ml and each bottle MRP Rs- 120/- Total value Rs. 2,040/- and marked as "Exhibit-A" out of which 01 (One) bottle taken as sample and marked as "Exhibit -A-1".

I, SI Uday Chakraborty of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Ajit Barman (61 yrs) S/O Late Danda Barman of Santinoy Colony, Biswakarama Mandir, PS- Matigara, Dist.- Darjeeling to the effect that today on 17.06.22 at 14.45 hrs received a source information that one person namely Ajit Barman (61 yrs) S/O Late Danda Barman of Santinoy Colony, Biswakarama Mandir, PS- Matigara, Dist.- Darjeeling is selling liquor in his residence at Santinoy Colony, Biswakarama Mandir under PS - Matigara, Dist.- Darjeeling without any valid license. Accordingly the fact is diarized in General Diary vide Matigara PS ODE No 975, Dated 17.06.22 and shared the information with O/C Matigara PS and as per his kind direction myself along with force had been to Santinoy Colony, Biswakarama Mandir under PS - Matigara, Dist.- Darjeeling to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the house of the above noted accused and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from his residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Ajit Barman (61 yrs) S/O Late Danda Barman of Santinoy Colony, Biswakarama Mandir, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 15.20 hrs to 16.20 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good will that a specific case may kindly be initiated against Ajit Barman (61 yrs) S/O Late Danda Barman of Santinoy Colony, Biswakarama Mandir, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
