(i) 16 (Sixteen) sealed bottles of 'Himalayan Gold 60 UP' Country Spirit each bottle containing 600 ml and each bottle MRP Rs- 120/= Total value Rs. 1,920/- and marked as "Exhibit-A" out of which 01 (One) bottle taken as sample and marked as "Exhibit -A-1".

I, SI Goutam Mallik of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Dhirendra Barman (63 yrs) S/O Late Debendra Barman of Sukanta Pally, Gas Godwn, PS-Matigara, Dist.- Darjeeling to the effect that today on 17.06.22 at 14.35 hrs received a source information that one person namely Dhirendra Barman of Sukanta Pally, Gas Godwn, PS-Matigara, Dist.- Darjeeling is selling liquor in his Tea Stall at Sukanta Pally under PS - Matigara, Dist. - Darjeeling without any valid license. Accordingly, the fact is diarized in General Diary vide Matigara PS GDE No 974, Dated 17.06.22 and shared the information with O/C Matigara PS and as per his kind direction myself along with force had been to Sukanta Pally under PS - Matigara, Dist.- Darjeeling to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the tea stall of accused Dhirendra Barman S/O Late Debendra Barman of Sukanta Pally, Gas Godwn, PS- Matigara, Dist.- Darjeeling and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his tea stall without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from his tea stall. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Dhirendra Barman (63 yrs) S/O Late Debendra Barman of Sukanta Pally, Gas Godwn, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 16.05 hrs to 16.45 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Dhirendra Barman (63 yrs) S/O Late Debendra Barman of Sukanta Pally, Gas Godwn, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
