Subject: FIR In producing herewith four (04) arrested accused persons namely (i) Rahul Rauth(23), S/O- Lt. Suraj Rauth of Patharghata, near Barsana Hotel, PS, Matigara, Dist.- Drjeeling (ii) Ramji Roy(24), S/O- Lt. Narayan Roy of Sutki Godwn, PS- Matigara, Dist.- Darjeeling (iii) Md. Sukurudin (30), S/O- Md. Samsur of Sutki Godwn, PS- Matigara, Dist.- Darjeeling and (iv) Md. Sajad(20), S/O- Lt. Md. Rafique of Sutki Godwn, PS- Matigara, Dist.- Darjeeling (not verified) arrested u/s- 41 Cr.P.C along with following seized articles viz: One iron made sword found from the possession of Rahul Rauth which was kept concealed on his back side under wearing apparel. (2) One iron made 'Knife' found from the possession of Ramji Roy which was kept in his right One iron made 'Kukri' found from the possession of Md. Sukurudin which was kept on (4) One iron made Crowbars found from the possession of Md. Sajad which was kept on his right hand. 1, PSI Shekhar Adhikary, S/O- Lt. Sonatan Adhikary of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Rahul Rauth(23), (ii) Ramji Roy(24), (iii) Md. Sukurudin (30), and (iv) Md. Sajad(20) and others to the effect that today on 18.06.2022 at 01.25hrs received a sources information that 12/14 youths have assembled at Chandmoni Ground back side of Chandmoni Temple under Matigara PS with a view to commit docoity in a house at Uttorayan township area. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Dhirendra Nath Mandal, ASI Tapan Das, C/1053 Poresh Rava, CV/387 Sukumar Barman and C/974 Mintu Sen, all of Matigara PS, SPC, left for the place to work out the information. At about 01.55 hrs. after reaching near Chandmoni Ground under PS-Matigara I met my source and being pointed by the source we started walking towards Chandmoni Ground, back side of Chandmoni Temple. At 02.15 hrs. we reached at Chandmoni Ground, back side of Chandmoni Temple and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted four (04) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation all the accused persons admitted that they had assembled there to commit dacoity in a house at Uttorayan Township area. I thereafter, seized the above noted weapons under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was made in between 03.05 hrs to 03.55 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them. I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Uttorayan Township area. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Rahul Rauth(23), S/O- Lt. Suraj Rauth of Patharghata, near Barsana Hotel, PS, Matigara, Dist.- Drjeeling (ii) Ramji Roy(24), S/O- Lt. Narayan Roy of Sutki Godwn, PS- Matigara, Dist.- Darjeeling (iii) Md. Sukurudin (30), S/O- Md. Samsur of Sutki Godwn, PS- Matigara, Dist.- Darjeeling and (iv) Md. Sajad(20), S/O- Lt. Md. Rafique of Sutki Godwn, PS- Matigara, Dist.- Darjeeling (not verified) and others and arrange for its investigation.
