Sir,

In producing herewith three (03) arrested accused persons namely (i) Gopal Mandal (25/M) S/O Ganendra Mandal of Subhashpally, Lichubagan, PS- Siliguri, Dist- Darjeeling (ii) Arjun Sahani (49/M) S/O Late Ramji Sahani of Mahabirsthan, kalahati, PS- Siliguri, Dist- Darjeeling and (iii) Swapan Das (23/M) Bishtu Das of Baribhasa, Hatath Colony, PS- Bhaktinagar, Dist- jalpaiguri arrested u/s- 41 Cr.P.C along with following seized articles viz:

- 1) One (01) iron made sword measuring 23 inch (approx) including wooden butt from the possession of Gopal Mandal which was kept concealed on his back side,
- 2) One (01) iron made Hasua measuring -17 inch (approx) from the possession of Arjun Sahani which was kept on his right hand,
- 3) One (01) iron made sabol measuring 18 inch (approx) from the possession of Swapan Das which was kept concealed on his back side,

I, ASI Md. Aminul Islam of Khalpara TOP under Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Gopal Mandal (ii) Arjun Sahani , (iii) Swapan Das and others namely to the effect that today on 17.06.2022 while my performing K-27 night mobile duty at about 00.10 hrs I received a sources information that 12/13 persons have assembled at **Ganga Nagar River Ghat** under Siliguri PS with a view to commit dacoity at Khalpara area. The fact was diarized in GD vide Khalpara TOP GDE No- 424 dated 17.06.2022. Subsequently, after sharing the information with I/C Siliguri PS and O/C Khalpara TOP and as per their direction, I along with ASI Sanjay Hasda, ASI- Kalachand Singha, ASI Md. Jinnat Ali C/1183 Nikhil Saha, C/174 Pradip Das, C/390 Sujit Paul, C/490 Gopal Mahato C/239 Badal Barman, CV/916 Amaresh Sah, CV/980 Ranjan Ojha, I met my source and being pointed by the source we started walking towards **Ganga Nagar River Side** After reaching **Ganga Nagar Ghat** started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted three (03) accused persons along with seized articles as mentioned above. However the other persons 1) Md. Kalu , 2) Md. Raja and others members managed to flee away from the spot taking the advantage of darkness and rainy. On interrogation the accused persons admitted that they had assembled here to commit dacoity in a house at Khalpara area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 00.35 hrs to 01.25 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Khalpara area. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Gopal Mandal (25/M) S/O Ganendra Mandal of Subhashpally, Lichubagan, PS- Siliguri, Dist- Darjeeling (ii) Arjun Sahani (49/M) S/O Late Ramji Sahani of Mahabirthan, kalahati, PS- Siliguri, Dist- Darjeeling and (iii) Swapan Das (23/M) Bishtu Das of Baribhasa, Hatath Coloney, PS_ Bhaktinagar, Dist- jalpaiguri and others and arrange for its investigation.
