**Sub: - F.I.R.**

Sir,

In producing herewith one arrested accused person namely Biswanath Biswas(58 Y) s/o Lt Dhirendra Nath Biswas of Vidya Chakra Colony, w/n-44, PS-Bhaktibnagar, Dist- Jalpaiguri along with seized articles:-

1. 11 (Eleven) Bottles Country Spirit styled as 60 UP PET Himalayan Gold of 600 ml each, MRP Rs.120/-
2. 01(One) Nylon Bag which used for carrying the seized articles SL. No. 1.

I, Asi Gopesh Chandra Barman of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that today i.e. on 17.06.2022 in course of my evening mobile van duty I received one secret source information to the effect that one person is carrying huge quantity of bottled country spirit through Pakur Tala More towards Swamiji More, Siliguri. Accordingly the information shared to O/C, Panitanki TOP and thereafter as per his direction I along with, Const/233 Narendra Nath Barman, CV-1007 Jiten Roy arrived at Pakur Tala More, Siliguri at 18.05 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of disinterested witnesses namely Sanahabaj(23) s/o Kormul Hoque of Bashbari, PO-Matigunda, PS- Islampur, Dist- Uttar Dinajpur present at Rented house c/o Khogen Das of Bhanu Nagar, w/n-42, PS-Bhaktinagar, Dist- Jalpaiguri. During interrogation the accused failed to produce any documents/license in support of the same and stated that he sale the same to the local public at Pakurtala More adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized (1) 11 (Eleven) Bottles Country Spirit styled as 60 UP PET Himalayan Gold of 600 ml each, MRP Rs.120/- and 2) One Nylon Bag which used for carrying the seized articles SL. No. 1 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 18.15 hrs. to 18.50 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities. As such there was no scope to serve Notice u/s 41A of Cr.P.C.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Biswanath Biswas(58 Y) s/o Lt Dhirendra Nath Biswas of Vidya Chakra Colony, w/n-44, PS-Bhaktibnagar, Dist- Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
