Respected Sir,

I Sri Rajib Sarkar, son of Sri Gopal Sarkar, resident of 45/3 Baghajatin Colony, P.O. & P.S. Pradhan Nagar, Siliguri, District: Darjeeling, would like to inform you that above named Riya Sarkar Talukdar, is wife legally wedded wife, and we got married in the year 2017, in the presence of both the family members, and out of our wedlock one daughter namely Miss Ridhi Sarkar, was born in the year of 2019, that since inception of our marriage my wife is not at all adjusting in nature and insist me always to leave my parental home, my parents are aged persons and I never agreed on the terms of my wife to leave my home, so she always use to physically assault my aged father and mother and disrespect them and always use filthy languages on them in presence of our servant and other family members. I would like to inform you that she is very desperate kind of a lady and she always use to black mail me that she will kill herself and my younger daughter and will make us responsible for that. The today at around 5.30 p.m. she again insisted me to leave my home and said me either I will leave my home or I will make my aged parents out of my home, and when I refused to accept any

of her terms she kicked my aged mother Ruma Sarkar, and brutally assaulted her also and when I protested against it she assaulted me also not only that her family members also came to my home and assaulted my father, and the said incident was happened in presence of the neighbour and my aged mother by seeing all this incident got a severe heart attack and now she is admitted in North Bengal Medica, and her present condition is serious and is at present admitted in ICU.

Under the above circumstances I do complaint against Riya Sarkar Talukdar and her family members namely Sri Gopal Sarkar and her wife, for physically assaulting my aged mother and father and me and for her and her family members my mother is fighting with her life. She and her family members also forcefully today signed in some blank documents and with those documents I have a doubt that she and her family members can extort me in future and also threatened me with dire consequences that they will lodge false complaint against me and my family members and will put us behind the bar. That before leaving the home today she and her family members took all the stridhan properties like almirah and jewellery items what she got during our marriage with her and also forcefully taken some jewelleries of my mother and a cash amount of Rs. 3,00,000/- from my home. Therefore I am writing this complaint before you to take a legal action against them as per law, for the interest of justice.
