Sir,

In producing herewith one accused person named Krishna Paudel (54) S/O- Lt. Babulal Paudel of Siliguri junction PS -Pradhan Nagar, Dist Darjeeling under arrest along with following articles under proper seizure.

1. 05 (Five) Bottles of Tuborg Strong Beer styled as TUBORG containing 650 ml, MRP Rs. 120/-.
2. 05 (Five) Bottles of Kingfisher Beer Strong styled as KINGFISHER containing 650 ml, MRP Rs. 120/-.

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Krishna Paudel (54) S/O- Lt. Babulal Paudel of Siliguri Junction, PS- Pradhan Nagar, Dist- Darjeeling to the effect that today on 18.06.2022 at 20:55 hrs received a source information that one person named Krishna Paudel (54) is selling liquor in his shop situated at Siliguri Junction under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with CV/128 Ajay kr Sahani, CV/242 Rakesh Monger and CV/223 Swapan Chettri had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of the information. On reaching there and as identified by the source it was found that one person was selling and storing liquor at his shop at Siliguri Junction under Pradhan Nagar PS. Subsequently, I along with my force cordoned the shop under Pradhan Nagar PS and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop under Pradhan Nagar PS. On demand he failed to produce any valid license/papers for selling and storing of such articles.

On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labelled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Krishna Paudel (54) S/O- Lt. Babulal Paudel of Siliguri Junction, PS- Pradhan Nagar, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21:25 hrs to 21:50 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Krishna Paudel (54) S/O- Lt. Babulal Paudel of Siliguri Junction, PS- Pradhan Nagar, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
