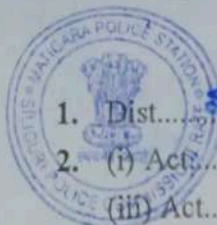

Sir,

With due respect and in producing herewith one Truck bearing Regd. No- HR 55 R 9509 under proper seizure, I ASI Joynul Abdin of Matigara PS, SPC do hereby lodge this written complaint against the driver of the above noted vehicle (HR 55 R 9509) to the effect that on 19.06.2022 at 21.55 hrs onwards in course of Mobile Van duty vide Matigara PS GDE No- 1087 Dated- 19.06.2022 and MCC No- 2155/2022 Dt. 19.06.2022 received information 06.05 hrs on 20.06.2022 that one vehicle got stuck up at Bailey Bridge constructed over damaged Balason Bridge. Accordingly, acting on the information I along with the force had been to the spot to verify the veracity of information and found that the above noted vehicle ((HR 55 R 9509) is standing over the bridge and the driver has already fled away from the spot.

Hence, it is evident that the driver of the vehicle (HR 55 R 9509) deliberately tried to cross the damaged bridge despite of knowing the fact that the vehicular flow of the heavy vehicle may cause damage to life and property.

Accordingly, I seized the vehicle bearing regd. No. HR 55 R 9509 under proper seizure in presence of witnesses.

Therefore I pray before you a specific case may kindly be started against the driver of the vehicle bearing Regd. No HR 55 R 9509 and arrange for its investigation.
