I, Praveen Agarwal, S/o Jagdish Agarwal, resident of Dwi Chowdhurani Road, Panchrai Nabanda Block B, Ward No. 42 of S.M.C., P.O. Seroke Road, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal beg to state that

on 20.06.2022 at around 08:30 pm my brother Abhishek Agarwal, S/o Jagdish Agarwal was travelling from New Life Fertility Centre, near Vishal Mega mart, Check Post towards his residence through NH 31 on one Gray coloured Honda scooter being no. NB74AW 0744. That at the traffic point at Check Post, near Eastern bypass one white coloured Ayudai Bon bearing no. WB72 H1290 was travelling negligently and the driver of the said vehicle was driving the said vehicle rashly and with negligence. The said vehicle was travelling from Champasari side and turning towards Eastern bypass at Check Post. The aforesaid vehicle rashly took the turn towards Eastern bypass when the traffic signal of their side was in a half/turned red. and the said vehicle rashly hit my brother travelling in the said scooter. That after my brother and his scooter was hit by the aforesaid vehicle my brother fell on the ground and sustained severe injuries. Thereafter the relatives and myself was informed about the

is under treatment.

It is mentioned here that there were 4-5 police
personnel at the place of incident and I believe there
are several video footage of the said incident which can
be obtained from the CCTV footage installed at the
Traffic point at the said Check Post traffic Junction.

The Driver of the said vehicle was driving
negligently on the wrong side and after the occurrence
of the said incident the driver fled away.

So, I therefore request you to kindly look into
the matter and do the needful under the provision of
Law.

I shall be highly obliged for this act of kindness.
